Re: EB-2019-0242 – Association of Major Power Consumers in Ontario (AMPCO) Application to review amendments the Market Rules made by the Independent Electricity System Operator (IESO).

AMPCO Statement of Costs: Amendment.

On February 6th we filed AMPCO's Statement of Costs herein. We write to amend (reduce) the costs claimed.

In our February 6th letter under which AMPCO's Statement of Costs was filed we noted in particular the inclusion of time spent by Mr. Dave Forsyth in support of AMPCO's work in preparation for, and during, the oral hearing. In following up on inquiries from OEB Staff reviewing the Statement of Costs for additional supporting material it has been brought to my attention that our previous reference to Mr. Forsyth as a consultant to AMPCO in this matter was incorrect.

Mr. Forsyth is actually contracted by AMPCO in an employment relationship (with the nature of his employment being entirely beyond the scope of his work on this particular matter).

Cognizant of the provision of the Board's *Practice Direction on Cost Awards* which specifies (section 6.05) that parties will not be compensated for time spent by its employees, though Mr. Forsyth's time on this matter was entirely incremental to his general responsibilities as an AMPCO employee, and as such will be incrementally compensated by AMPCO, AMPCO has instructed that its claim for

recovery of its reasonably incurred costs in this matter should be reduced to remove any claim for recovery of costs incurred for Mr. Forsyth's hearing support.

Accordingly, filed with this letter is an amended *Summary of Fees and Disbursements* through which AMPCO's cost claim is reduced by the \$22,858.77 amount set out in the previously filed *Detail of Fees and Disbursements Being Claimed* for Mr. Forsyth's time.

As I was the affiant in support of the accuracy of AMPCO's Statement of Costs, I assume that the Board can accept this letter and the amended *Summary of Fees and Disbursements* attached in amendment of AMPCO's Statement of Costs. Should the Board require anything further in this respect please let us know.
