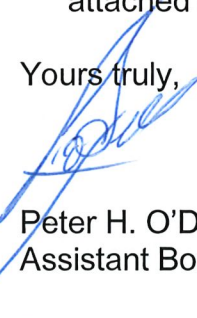

DECISION AND ORDER

Enbridge Gas Distribution Inc. ("Enbridge") filed an application dated February 22, 2007 with the Ontario Energy Board (the "Board") under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"), for an order of the Board that cancels an existing Certificate of Public Convenience and Necessity ("Certificate") for a former municipality that is now part of The Nation Municipality (the "Municipality") and replaces the existing Certificate with a new Certificate for the Municipality. The Board has assigned file number EB-2007-0059 to this application.

The Board's Notice of Application and Written Hearing was published on February 15, 2007. There were no intervenors.

On January 1, 1998, the former Township of Cambridge, the former Township of South Plantagenet, the former Township of Caledonia and the former Village of St. Isidore were amalgamated to form the Township of the Nation. The name was subsequently changed to The Nation Municipality on April 11, 1998.

Enbridge currently holds a Certificate (E.B.C. 214) and franchise agreement for only the geographical area formerly known as the Township of Cambridge and wishes to expand its service to other parts of the Municipality. There are no gas utilities, other than Enbridge in this area.

The nearest natural gas utility other than Enbridge is Union Gas Limited in North Stormont, in the United Counties of Stormont, Dundas and Glengarry.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

IT IS THEREFORE ORDERED THAT:

1. The Certificate of Public Convenience and Necessity for the former Township of Cambridge (E.B.C. 214) is cancelled.
2. A Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Enbridge Gas Distribution Inc. to construct works to supply gas in The Nation Municipality.
