**RE: EB-2019-0261 Hydro Ottawa Limited 2021-2025 Rates Application
Energy Probe Late Intervenor Request Letter**

Energy Probe Research Foundation (Energy Probe) applies for late intervenor status in the EB-2019-0261 proceeding, the application by Hydro Ottawa Distribution Inc. to the Ontario Energy Board for approval of electricity distribution rates for the 2021-2025 period. Energy Probe apologizes for the late intervention and hopes that the OEB and the applicant will accept it.

Energy Probe attended the June 11, 2019 Hydro Ottawa Presentation Day and expected to be notified of the filing of the application. However, the OEB's Letter of Direction of March 4, 2020 directed Hydro Ottawa to only notify the EB-2015-0004 intervenors and did not mention the Presentation Day participants. Energy Probe was not an intervenor in the EB-2015-0004 proceeding and was not notified of the application.

Statement of Interest

Energy Probe is a non-profit environmental and consumer organization which promotes economic efficiency in the use of resources. Energy Probe will be representing its electricity residential customer supporters, which we have some number of thousands. Energy Probe expects that it will focus on the following parts of the application:

- The proposed Custom IR rate setting formula and the Custom Performance Scorecard
- The Load Forecast for 2021 to 2025,
- The Distribution System Plan and the forecast of capital expenditures for 2021 to 2025,

- Revenue to Cost ratios and Rate Design,
- The balances in Deferral and Variance Accounts and the proposed disposition.
