Response

The table on page 9 of Exhibit K6.1 has been appended with column (c) added to indicate total amounts already in rate base ("in-service") as of December 31, 2007. The updated table is provided below.

To facilitate review and approval of the planned additions to rate base, three other columns have been added to the attached table:

Column (d) presents the 2007 year-end Construction-in-Progress (CIP) value for each project, reflected in the 2007 OPG year-end audited financial statements. As indicated in the response to Undertaking J2.7, it is OPG's position that these CIP values (reconciled to the \$210M presented in the 2007 year-end financial statements) are required to be accepted by the OEB.
 Column (g) presents the 2008 and 2009 in-service additions net of YE 2007 CIP

values. The amount in column (g) is the amount which is subject to OEB review in

this application.

Column (h) provides information on which projects coming in-service in 2008 and 2009 are achieving their <u>final</u> in-service designation during 2008 or 2009. Where "Yes" is indicated in that column, the project will achieve its final in-service designation and the project will be essentially complete, although there may still be minor project close-out costs coming into rate base following the test period. Projects indicating "No" for final in-service status have partial in-service amounts during the test period and will have additional in-service additions beyond the test period.
