## **LETTER OF DIRECTION**

Dear Mr. Denomy:

Re: Enbridge Gas Inc. (Enbridge Gas)

Kimball-Colinville and Payne Well Drilling Project Ontario Energy Board File Number: EB-2020-0105

The Ontario Energy Board (OEB) has issued its Notice of Hearing for Enbridge Gas' above-referenced application (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's media agent, which were copied to you. Please note that you must comply with the directions in paragraphs 2 and 3 below **prior to May 14, 2020**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at Registrar@oeb.ca.

## You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed project.
- 2. No later than the date the Notice is posted on Enbridge Gas' website in accordance with paragraph 3, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter, and the application and the evidence, directly on each of the following:
  - a. all property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1 above
  - b. the clerks of St. Clair Township and the County of Lambton

- c. all Indigenous Communities with lands or interest in the lands directly affected by the proposed project
- d. the Métis Nations of Ontario, Lands, Resources and Consultation Office, 75 Sherbourne St., Suite 311, Toronto, Ontario M5A 2P9
- e. all affected utilities and railway companies
- f. members of the Ontario Pipeline Coordinating Committee
- g. The Ministry of Natural Resources and Forestry, Petroleum Operations Section, London, Ontario
- h. St. Clair Region Conservation Authority

(Note: It is acceptable to serve the evidence by e-mail provided the recipient has stated their preference for the same.)

- 3. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Enbridge Gas' office and in a prominent place on Enbridge Gas' website.
- 4. To file with the OEB, in both electronic and hard copy format, affidavit evidence proving completion of the matters in paragraphs 1 through 3 above immediately thereafter, with the relevant Notices and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
- 5. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
