We are counsel to APPrO in above captioned matter.

On May 14, 2020, the Ontario Energy Board (the "Board" or "OEB") issued a letter stating that it is commencing consultation on a deferral account relating to impacts arising from the COVID-19 emergency (the "Account") in the electricity and gas sectors (the "Consultation").

The OEB has invited interested stakeholders to participate in this consultation.

APPrO represents, among other types of generation, the majority of gas-fired generators in Ontario, and wishes to participate. APPrO is participating only as it relates to the Account established by Enbridge Gas Inc. as it affects gas-fired generators who are its customers.

APPrO and Its Interest in the Consultation

APPrO is a non-profit organization representing more than 100 companies involved in the generation of electricity in Ontario, including generators and suppliers of services, equipment and consulting services. APPrO's members produce electricity from natural gas, hydro, nuclear, wind, biogas and other sources. APPrO's members have a direct and significant interest in the Consultation as among APPrO's members are gas-fired generators who are customers of Enbridge Gas Inc. in both Enbridge Gas Distribution Ltd. and Union Gas Ltd. franchise areas. Enbridge Gas Inc. as a natural gas distributor has been ordered to establish the Account based on the Board's accounting order dated March 25, 2020¹.

APPrO's interest in this matter is in respect of the establishment of the Account by Enbridge Gas Inc. and all related issues arising therefrom, as it affects the gas-fired generators who are its customers.

APPrO's Experience as a Frequent Intervenor

APPrO has a record of frequent participation in OEB proceedings as an intervenor. This includes proceedings involving Hydro One Networks Inc., Enbridge Gas Ltd., Union Gas Ltd., Enbridge Gas Distribution Inc., the Independent Electricity System Operator and the former Ontario Power Authority, as well as OEB-sponsored consultations.

Nature and Scope of APPrO's Intended Participation
