Dear Ms. Long:

Re: EB-2019-0183 – Enbridge Gas Inc. Owen Sound LTC and M17 Rate – Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets. Time spent by co-counsel, Jay Shepherd, has not been claimed.

SEC notes, that in its letter accepting Enbridge Gas' withdrawal of its EB-2018-0244 application, the Board stated that it "will consider the cost claims of intervenors who were found eligible for costs in the M17 rates proceeding (EB-2018-0244) in the upcoming Owen Sound line leave to construct and M17 rates application."¹ On that basis, SEC has included its claim for costs for the EB-2018-0244 proceeding in its cost claim. To help identify that claimed time, we have separated out the two proceedings within the Board's Cost Claim form.

For the purposes of the Board's form we have also included time in the 'Other Conference – Preparation' category for time docketed for items that do not fall within the other categories (i.e. filing Notice of Intervention, procedural matters, reviewing the final decision, reviewing the DRO, and steps related to EPCOR's motion in EB-2018-0244 proceeding etc.).

As a result of COVID-19 remote work environment, we have not been able to easily arrange to have the Board's cost claim affidavit commissioned. In place of a commissioned affidavit, I have provided below in this signed letter, the same statements that are on the Board's cost claim affidavit, for the purposes of attesting to the accuracy of the enclosed cost claim.

We hope in the current circumstances that this is acceptable to the Board.

In lieu of a commissioned affidavit, and as a member of the Law Society of Ontario and an Officer of the Ontario Court and, as such, mindful of my duties to the Ontario Energy Board, I, Mark Rubenstein, provide this statement confirming that;
