**Re: Ameresco JPII Carbon Reduction Inc.
Application for Electricity Storage Licence
OEB File Number EB-2020-0153**

The Ontario Energy Board (OEB) received Ameresco JPII Carbon Reduction Inc.'s (Ameresco) application for an electricity storage licence on June 01, 2020. The OEB has assigned file number EB-2020-0153 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

The OEB has preliminary reviewed your application. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Section 9. Facility Description

- a) Please confirm whether Ameresco intends to sell ancillary services. If yes, please describe services Ameresco intends to sell.
- b) Please provide a facility name and address as required in this section.

- c) Please indicate whether Ameresco is a party to any procurement contract. If yes, please identify the type on the contract and the expiry date of the contract. If no, please explain how Ameresco intends to operate in the market.

2. Section 11. Connection

Question (a) requires Ameresco to describe the existing or future distribution system from the output of the storage facility to the connection point with the electricity distributor. This information has not been provided.

- a) Please provide information on the distribution assets as required in this section.

3. Section 12. Corporate Organization

Question (b) requires Ameresco to provide a description of the applicant's current business activities and the applicant's corporate organization including the applicant's relationship with its affiliates and associated entities. Although Ameresco provided a corporate organization chart, as required in section 12 (a), information required in section 12 (b) has not been provided.

- a) Please describe Ameresco's business activities and its relationship with affiliates and associated entities.

4. Section 13. Finance

1. To satisfy requirements of this section, Ameresco provided financial statements of its parent company, Ameresco Inc. As per this section requirement, if the applicant submits the financial statements of its parent company, the applicant must also provide a parental guarantee. Parental guarantee has not been provided.

- a) Please provide a parental guarantee as required in this section.

2. In the response to question (c), Ameresco stated that it has not secured financing of the projected capital cost identified in section (b).

- a) Please describe Ameresco's plans to finance this project.

5. Section 14. Technical Resources.

In this section Ameresco identified Rodan Energy Services as the company that will be contracted to operate the storage facility.

- a) Please provide a description of Rodan Energy Services and identify specific services that this company will be providing to Ameresco.

The OEB will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
