### Re: EB-2019-0194 - Enbridge Gas Inc. 2020 Rates - Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets.

Both of SEC's counsel were involved in the proceeding. Mr. Shepherd handled all aspects of Phase 1 and leveraged his involvement in Enbridge's 2019 application to review parts of the ICM component of Phase 2.
