2021 Dawn Parkway Expansion Project – Comments on Cost Claims**

Pursuant to the Ontario Energy Board’s (“OEB” or “Board”) Procedural Order No. 7 and Decision on Adjournment (dated May 19, 2020) for the above-noted proceeding, Enbridge Gas Inc. (“Enbridge Gas”) is in receipt of cost claim submissions from:

- Association of Power Producers of Ontario (APPrO),
- Building Owners and Managers Association - Greater Toronto (BOMA),
- Consumers Council of Canada (CCC),
- Canadian Manufacturers & Exporters (CME),
- Environmental Defence (ED),
- Energy Probe Research Foundation,
- Federation Rental-housing Providers of Ontario (FRPO),
- Green Energy Coalition (GEC),
- Industrial Gas Users Association (IGUA),
- Low-Income Energy Network (LIEN),
- London Property Management Association (LPMA),
- Pollution Probe (PP),
- School Energy Coalition (SEC), and
- Vulnerable Energy Consumers Coalition (VECC).

As no expert evidence has been provided to Enbridge Gas at this time, it is not possible to comment on its relevance in light of the Board’s expectations set out in Procedural Order No. 3 (dated April 2, 2020), “...that intervenors filing evidence will ensure that the evidence is within the scope of the approved Issues List, and will coordinate their efforts to avoid duplication.”

If the Board determines that it is appropriate to award the costs submitted by cost eligible intervenors at this time, Enbridge Gas suggests that it is also appropriate take such interim

awards into account at the time that final costs are assessed once the relevance and overall contribution of intervenors (and any expert evidence they produce) can be assessed.

With the exception of the comments above, Enbridge Gas has no specific concerns with the cost claim submissions.
