**IN THE MATTER OF** the *Ontario Energy Board Act* 1998, S.O.1998, c.15, (Schedule B);

**AND IN THE MATTER OF** an application by Pearson International Fuel Facilities Corporation pursuant to section 101 of the *Ontario Energy Board Act, 1998* for an order or orders granting Pearson International Fuel Facilities Corporation authority to construct a work under a highway for the purposes of constructing a jet fuel pipeline.

#### PROCEDURAL ORDER NO. 1

Pearson International Fuel Facilities Corporation (the "Applicant") has filed an application with the Ontario Energy Board, (the "Board") dated April 21, 2008, under section 101 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B (the "Act") in relation to the construction of a jet fuel pipeline (the "Project"). The Applicant was granted leave to construct for the Project on August 17, 2007 (proceeding EB-2007-0009). The Board has assigned file number EB-2008-0091 to this application.

The Project involves the construction of approximately 5.6 kilometres of 16 inch diameter jet fuel pipeline in the City of Mississauga. The proposed pipeline will extend from a new bulk fuel storage facility on Torbram Road in a southeasterly direction along Torbram Road and Kimberly Street, through a portion of land owned by the Greater Toronto Airports Authority, across Derry Road and into the Lester B. Pearson International Airport.

The Applicant states that it has been unable to negotiate the necessary license agreements with the Region of Peel and the City of Mississauga. It is therefore seeking an order or orders of the Board, pursuant to section 101 of the Act, authorizing the construction of works under Derry Road and on City of Mississauga road allowances.

The Board issued a Notice of Application and Hearing on May 16, 2008. The Notice of Application and Hearing was served by the Applicant as directed by the Board. An intervenor list is attached as Appendix "A" to this Procedural Order.

The Board has determined that it is appropriate in this case to provide a further opportunity for the parties to attempt to reach agreement on outstanding issues and will therefore direct the parties to participate in a settlement conference. In the event that the issues are not resolved by the parties, a date will be set for an oral hearing on the matter.

The Board considers it necessary to make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

#### THE BOARD ORDERS THAT:

 Pearson International Fuel Facilities Corporation, the Regional Municipality of Peel and the City of Mississauga are directed to attend at a settlement conference commencing at 9:30 a.m. on Thursday July 3, 2008 and continuing, if necessary, on Friday July 4, 2008.
