LETTER OF DIRECTION

Dear Mr. Torul:

**Re: Enbridge Gas Inc. (Enbridge Gas)
Application for 2021 Rates
Ontario Energy Board File Number: EB-2020-0095**

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas' application for 2021 Rates (Notice). The English and French versions of the Notice will be published by the OEB, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 through 3 below **prior to July 25, 2020**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at Registrar@oeb.ca.

You are directed:

1. No later than the date the Notice is posted on Enbridge Gas' website in accordance with paragraph 2, to arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, directly on:
 - i. the clerks of all municipalities in which Enbridge Gas supplies gas;
 - ii. the band councils of all Indigenous communities and First Nation Reserves to which Enbridge Gas supplies gas;
 - iii. the Métis Nation of Ontario;
 - iv. all intervenors in the past and current proceedings EB-2017-0306, EB-2017-0307, EB-2019-0194 and EB-2019-0105;
 - v. all natural gas distributors in Ontario that take natural gas service from Enbridge Gas.

2. To make a copy of both the English and French versions of the Notice, the application and the evidence, and any amendments thereto, available for public review at Enbridge Gas' office, legacy Union Gas Limited's office and in a prominent place on Enbridge Gas' website.
3. If Enbridge Gas has a twitter account, once both the English and French versions of the Notice are posted on Enbridge Gas' website in accordance with paragraph 2, to tweet the following messages:
 - a. "We have applied to the @OntEnergyBoard to increase our natural gas distribution rates. Learn more. Have your say." The tweet is required to provide a live link to the English Notice posted on Enbridge Gas's website.
 - b. « Nous avons déposé une requête auprès de @OntEnergyBoard afin d'augmenter nos tarifs de distribution de gaz naturel. Soyez mieux renseigné. Donnez votre opinion. » The tweet is required to provide a live link to the French Notice posted on Enbridge Gas's website.
4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above immediately thereafter.
5. To provide a copy of the Notice, the application and the evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
