

Brian,

Further to our discussion yesterday, Jane and I are available on Thursday October 3 at 9 am for a meeting to discuss the Windsor Line Project. If this date doesn't work let me know.

In addition and in discussion with Mark Murray, the County had a site meeting with your team on August 13 (with the Town of Lakeshore) and reviewed the initial proposed running line within the County right of way. It was identified at the meeting that the proposed running line was not a preferred location based on proximity to the edge of roadway. As a result of that meeting, the pipeline was requested to be relocated closer to the property line. The County was awaiting updated drawings on the new proposed running line for review. It would be advantageous to receive these in advance of the meeting.

Let me know if October 3 works for your team.
