Re: EB-2019-0082 – Hydro One Transmission 2020-2022 Rates – Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Enclosed, please find SEC's cost claim in this matter on the Board's form with accompanying detailed dockets.

SEC participated in the material aspects of this complex proceeding, in which Hydro One sought approval of a proposed revenue requirement of over \$5Bn over the three-year rate term. The hearing included a 2-day Technical Conference, a 9-day Oral Hearing, and the need for a detailed Final Argument. SEC split its responsibilities between two counsel with each having separate areas of responsibility. There was no material overlap and SEC believes that approach led a high-level of efficiency.

SEC took the lead amongst intervenors in a number of areas, including review of Hydro One's \$3.86Bn capital plan, which was the largest driver of the proposed rate increase.

For the purposes of the Board's form, we have included time, in review the undertakings, arising from the Technical Conference in the 'Oral Hearing – Preparation' Category, and the undertaking from the Oral Hearing in the 'Argument' category. We have also used the 'Other Conference – Preparation' category for time docketed for items that do not fall within the other categories (i.e. filing Notice of Intervention, procedural matters, submissions on confidentiality, discussions amongst parties to develop the Issues List, reviewing the final decision, reviewing and filing submissions on the Draft Rate Order, client reporting, etc.).

SEC submits that its participation in this proceeding was thorough and valuable, and was designed to maximize its assistance to the Board. SEC therefore requests reimbursement of its reasonably incurred costs as set forth in the attached cost claim.

Due to technical difficulties related to the undersigned having limited internet access at this time, SEC has been unable to have the Board's affidavit remotely commissioned in time for filing this cost claim. SEC will endeavor to have the signed affidavit filed with the Board by August 4, 2020.
