Re: Guidance on Covid-19 Energy Assistance Program – Small Business Implementation and Related Materials – OEB File No. EB-2020-0185

The Ontario Energy Board (OEB), of its own motion, has today amended the licences of all licensed electricity distributors (Distributors) and unit sub-meter providers (USMPs) to support the implementation of the Government of Ontario's new COVID-19 Energy Assistance Program – Small Business (CEAP-SB). The purpose of this letter is to provide further details relevant to the implementation of CEAP-SB.

In the Decision and Order (Decision), the OEB has determined that the \$8 million in funding provided by the Government will be allocated based on the number of GS<50 kW customers for Distributors and the number of customers in the relevant commercial class whose annual usage is less than 150,000 kWh for USMPs, as reported to the OEB. A total of \$4.625 million will be allocated to Distributors, and \$53,700 to USMPs. The Decision indicates that the individual allocations for each Distributor and USMP would be provided by the OEB in separate correspondence, these allocations are set out in Appendix A to this letter. As explained in the Decision the funds will be provided by the Independent Electricity System Operator through a reimbursement for all credits provided to eligible consumers.

The Licence conditions prescribe the use of an application form that reflects the eligibility criteria set out in the Decision and requires the licensees to provide it for use by consumers who are seeking CEAP-SB funding. The OEB has prepared an application form in cooperation with the Ministry of Energy, Northern Development and Mines (Application Form) which is attached as Appendix B to this letter in English with a translated French version to follow shortly. The OEB will also provide a final Application Form in both official languages and in an online, fillable PDF.

As part of the implementation of the CEAP residential program, OEB staff provided a slide deck with guidance to Distributors, USMPs and natural gas utilities. The deck included a glossary of terms, eligibility, application processing, expected timelines, application of the credit to eligible customer accounts and reporting and record keeping requirements. As the much of the guidance provided in that deck applies, with necessary modification, to CEAP-SB, OEB staff is suggesting Utilities refer to the CEAP residential program implementation deck for guidance when implementing CEAP-SB.

There are, however, two elements of guidance specific to eligibility for CEAP-SB that OEB staff is providing to utilities. Firstly, as noted in the Decision, to achieve the Ministers' goal of helping small business and registered charity customers who need the most help due to the impact of COVID-19, the OEB has interpreted "closed" as meaning the small business or registered charity was unable to maintain regular operations to the public as a result of the requirement to either fully close or limit access to their premises. To assist Utilities in responding to enquiries from customers about CEAP-SB eligibility, OEB staff is providing examples of what closures might include, but are not limited to:

- Personal services (e.g. hair salon, chiropractor) that had to fully close
- A restaurant or coffee shop that had to close regular dining operations and provided only takeaway or delivery service.
- A small fashion retailer or pet store whose premises was closed to the public but was able to provide contactless curbside pick for customers.
- A non-publicly funded registered charity whose premises was closed to the public but was able to adapt to provide limited services remotely.

Accounting Guidance

Note that the following accounting guidance applies to CEAP-SB as well as the CEAP residential program that was discussed in the OEB's July 16, 2020 Guidance. The CEAP-SB and CEAP residential program are being funded through provincial revenues. The IESO has informed the Utilities that CEAP-SB and CEAP residential program reimbursements will appear as charge type 1477 "Covid-19 Energy Assistance Program (CEAP) Settlement Amount" on the IESO invoice. Electricity distributors are to record the reimbursements as per the IESO invoice and amounts credited to eligible customers in new Accounts Payable or Accounts Receivable sub-accounts. CEAP-SB and CEAP residential program related transactions will not flow through expenses, revenues or variance accounts.

Electricity distributors must perform monthly reconciliations between the CEAP-SB and CEAP residential program amounts credited on customers' bills, and the amounts reimbursed from the IESO to ensure that they are kept whole, and do not exceed the funding allocated to them.

INSTRUCTIONS

Please complete only one electricity application for your registered small business or registered charity. You cannot receive COVID-19 Energy Assistance Program for Small Business (CEAP-SB) funding for multiple storefronts or locations, and you can only receive CEAP-SB funding from your electricity provider once. If you have natural gas service, you may also be able to apply separately for natural gas CEAP-SB support through your natural gas utility.

After you have provided your information, please sign this form and provide your consent by: (a) if submitting electronically, typing your name(s) in Section 4; or (b) if submitting by mail, you may print the completed form and sign Section 4 by hand. Please ensure that the information provided is accurate and up-to-date.

Once completed, the form can be emailed or printed and mailed to your utility. Your utility may offer other ways to submit your application, including in some cases by phone. Please refer to your utility's website or contact them for more details.

CEAP-SB funding is limited and applying does not guarantee that your utility has CEAP-SB funding remaining. Applications will be processed in the order they are received. For information on residential CEAP and lower-income energy support programs available, please visit the Ontario Energy Board's website.

PROGRAM ELIGIBILITY

You are eligible for this program if you meet all of the following criteria:

- As of the date you are applying, your small business or registered charity has an
 active account with an electricity distributor or a unit sub-meter provider. You will
 be required to provide your registered business number or charitable registration
 number.
- 2. Your small business or registered charity is using less than 150,000 kWh of electricity annually if the account is with a unit sub-meter provider.
- 3. Your small business or registered charity is classified as a general service < 50 kW customer if the account is with an electricity distributor.
- 4. Your small business or registered charity did not have any overdue amounts on its electricity bill on March 17, 2020, the date of the Provincial Declaration of Emergency.

- 5. As of the date you are applying, your small business or registered charity has any overdue amounts owing from at least two electricity bills since March 17, 2020.
- 6. Your small business or registered charity was required to close its premises to members of the public for regular operations for at least fifteen days as a result of a government order or an inability to adapt your business or charity to comply with public health recommendations.

You may be eligible for an enhanced credit if your small business or registered charity's main heating source is electricity.

If you are not eligible for CEAP-SB, your place of residence may still be eligible for residential CEAP or lower-income energy support programs. Please contact your utility for information on entering into a payment agreement. You may also visit the Ontario Energy Board's website for more information .

When submitting this completed form to your utility, please do not provide any personal information. The term "personal information" has the same meaning as under the *Freedom of Information and Protection of Privacy Act*, R.S.O. 1990 c. F.31. Please note that information requested in this form is business identity information (i.e. name, title, and business contact information), not personal information.
