Kitchener-Wilmot Hydro Inc. has applied to change its electricity distribution rates effective January 1, 2021.

Kitchener-Wilmot Hydro Inc. has applied to the Ontario Energy Board to change its electricity distribution rates effective January 1, 2021. If the application is approved as filed, a typical residential customer of Kitchener-Wilmot Hydro Inc. would see an increase of approximately \$0.48 per month. Other customers, including businesses, may also be affected.

The requested rate increase is set using an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency. Kitchener-Wilmot Hydro has also applied to recover certain labour costs for the connection of renewable generation investments and related depreciation costs.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Kitchener-Wilmot Hydro's application. We will determine whether the company has used the applicable models and formulas required by the OEB and whether to approve Kitchener-Wilmot Hydro's request related to renewable generation investments. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate change will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Kitchener-Wilmot Hydro's application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about Kitchener-Wilmot Hydro's application and make arguments on whether the OEB should approve Kitchener-Wilmot Hydro's request. Apply by **September 21, 2020** or the hearing will go ahead without you and you will not receive any further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and only in relation to Kitchener-Wilmot Hydro's request to recover certain labour and depreciation costs related to eligible renewable generation investments.

If you apply to become an intervenor, all information will be public.
