DECISION AND ORDER

Union Gas Limited ("Union") filed an application dated September 14, 2006 with the Ontario Energy Board under the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended, for an order of the Board to establish a single Certificate of Public Convenience and Necessity ("Certificate") for the former entities now incorporated within the Township of Mattice Val - Côté (the "Municipality"). The Board has assigned file No. EB-2006-0223 to this application.

An Act of the Government of Ontario to continue the Corporation of the Union of the Townships of Eilber and Devitt under the name of the Corporation of the Township of Mattice - Val Côté was given Royal Assent on November 9, 1983 and was effective January 1, 1984.

Union is presently serving the Municipality and has a Certificate (E.B.C. 40) for the former unorganized Township of Eilber. The geographic area of the former Township of Devitt does not currently have natural gas service and Union does not hold a Certificate for that area. Union has advised that it is the only gas utility in the area.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

IT IS THEREFORE ORDERED THAT:

1. The approval granted under the existing Certificate of Public Convenience and Necessity (E.B.C. 40) covering the former unorganized Township of Eilber is cancelled.
2. A Certificate of Public Convenience and Necessity, attached as Appendix A, is granted to Union Gas Limited to construct works to supply gas in the Township of Mattice Val - Côté.
