Elexicon Energy Inc. has applied to raise electricity distribution rates in its Veridian Rate Zone, effective January 1, 2021.

Elexicon Energy Inc. has applied to the Ontario Energy Board to raise electricity distribution rates in its Veridian Rate Zone effective January 1, 2021. If the application is approved as filed, a typical residential customer in the Veridian Rate Zone would see an increase of approximately \$0.90 per month. Other Veridian Rate Zone customers, including businesses, may also be affected.

The requested rate increase is set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. The rate increase includes Elexicon Energy Inc.'s request to align the rate year in the Veridian Rate Zone to match its fiscal year and to recover forgone revenue, resulting from the deferment of the implementation of its 2020 rates because of the Covid-19 emergency.

Elexicon Energy Inc. has also applied for approval on a final basis of costs associated with the connection of renewable generation projects.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Elexicon Energy Inc.'s application. We will determine whether the company has used the applicable models and formulas required by the OEB and whether to approve its other requests. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Elexicon Energy Inc.'s application on the OEB's website now
- · You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about Elexicon Energy
 Inc.'s application and make arguments on whether the OEB should approve the company's request.
 Apply by September 24, 2020 or the hearing will go ahead without you and you will not receive any
 further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

The OEB intends to consider cost awards in this proceeding that are in accordance with the *Practice Direction on Cost Awards* and only in relation to Elexicon Energy Inc.'s request for final approval of costs associated with the connection of renewable generation projects.
