1. I am the Vice President, Regulatory Affairs of Alectra Utilities Corporation and as such, I  
have knowledge of the matters hereinafter deposed.

2. Pursuant to Paragraph 1 of the Ontario Energy Board's (the "OEB's") September 1, 2020  
Letter of Direction, in this proceeding, I did arrange for the immediate service of the English and
