

Oshawa PUC Networks Inc.

**Application for electricity distribution rates and other
charges beginning January 1, 2021**

**PROCEDURAL ORDER NO. 1
September 14, 2020**

Oshawa PUC Networks Inc. (Oshawa PUC Networks) filed a cost of service application with the Ontario Energy Board (OEB) under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that Oshawa PUC Networks charges for electricity distribution, beginning January 1, 2021. The application was accepted by the OEB as complete on August 19, 2020.

A Notice of Hearing was issued on August 19, 2020. Each of Association of Major Power Consumers in Ontario (AMPCO), Consumers Council of Canada (CCC), Distributed Resource Coalition (DRC), Energy Probe Research Foundation (Energy Probe), Pollution Probe, School Energy Coalition (SEC) and Vulnerable Energy Consumers Coalition (VECC) applied for intervenor status and cost eligibility.

No objection was received from Oshawa PUC Networks.

AMPCO, CCC, DRC, Energy Probe, Pollution Probe, SEC, and VECC are approved as intervenors. The list of parties in this proceeding is attached as Schedule A to this Procedural Order. AMPCO, CCC, DRC, Energy Probe, Pollution Probe, SEC, and VECC are eligible to apply for an award of costs under the OEB's [Practice Direction on Cost Awards](#).

Cost eligible intervenors should be aware that the OEB will not generally allow the recovery of costs for the attendance of more than one representative of any party, unless a compelling reason is provided when cost claims are filed.

Being eligible to apply for recovery of costs is not a guarantee of recovery of any costs claimed. Cost awards are made by way of OEB order at the end of a hearing.

Issues List

It is the OEB's expectation that parties will be best positioned to identify issues relevant to Oshawa PUC Networks' application after the applicant has responded to interrogatories. Oshawa PUC Networks, OEB staff and the intervenors shall develop and OEB staff shall file a proposed issues list for the OEB's consideration. The OEB will approve an issues list prior to the settlement conference.

Interrogatories

At this time, provision is being made for written interrogatories. The OEB will review the single test year application both in the context of the projects and programs that are requested for the test year and from the perspective of the distributor's plans for the subsequent four years until the next scheduled rebasing application.

Parties should examine the value presented by the proposed investments as opposed to focusing only on the costs. Parties should also assess the fit between the applicant's plans and its stated objectives, and consider how the plans contribute to positive outcomes for customers, in particular those outcomes that arise from the asset management decisions reflected in the applicant's distribution system plan. The OEB will consider the entire five-year distribution system plan to assess the planning and pacing proposals of the applicant and whether the test year requests are appropriately aligned with the distribution system plan. The OEB will also consider productivity and benchmarking results in assessing cost forecasts, bill impacts and distributor performance.

Parties should not engage in detailed exploration of items that do not appear to be material. Parties should use the materiality thresholds documented in Chapter 2 of the Filing Requirements as a guide. In making its decision on cost awards, the OEB will consider whether intervenors made reasonable efforts to ensure that their participation in the hearing was focused on material issues.

Parties should consult sections 26 and 27 of the OEB's [Rules of Practice and Procedure](#) regarding required naming and numbering conventions and other matters related to interrogatories.

Presentation Of Settlement Proposal

Following the settlement conference, provision is being made for the presentation of any settlement proposal filed by Oshawa PUC Networks, whether full or partial, and for the presentation of any unsettled issues to be adjudicated by the OEB. Oshawa PUC Networks' presentation is intended to summarize and provide any salient information for the OEB's consideration in reviewing the settlement proposal.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any relevant information and documentation from Oshawa PUC Networks that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by **September 25, 2020**.
2. Intervenors shall request any relevant information and documentation from Oshawa PUC Networks that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by **September 30, 2020**.
3. Oshawa PUC Networks shall file with the OEB complete written responses to all interrogatories and serve them on all intervenors by **October 20, 2020**.
4. OEB staff shall file a proposed issues list, or, alternatively, shall advise the OEB in writing that the parties and OEB staff have been unable to reach an agreement on a draft issues list by **October 30, 2020**.
5. A settlement conference among the parties and OEB staff will convene on **November 9, 2020**, starting at 9:30 a.m., with the objective of reaching a settlement among the parties on the issues. If necessary, the settlement conference will continue on **November 10 and 11, 2020**. Instructions on whether the settlement conference will be an in-person event or a virtual event will be communicated later.

6. Any settlement proposal arising from the settlement conference shall be filed with the OEB on or before **December 7, 2020**. In addition to outlining the terms of any settlement, the settlement proposal should contain a list of any unsettled issues, indicating with reasons whether the parties believe those issues should be dealt with by way of oral or written hearing.
7. Any submission from OEB staff on a settlement proposal shall be filed with the OEB and served on all parties by **December 14, 2020**.
8. If there is no settlement proposal arising from the settlement conference, Oshawa PUC Networks shall file a statement to that effect with the OEB by **November 27, 2020**. In that event, parties shall file and serve on the other parties by **December 4, 2020**, any submissions on which issues shall be heard in writing, and for which issues the OEB should hold an oral hearing.
9. The OEB is setting a tentative date of **January 7, 2021**, to present to the OEB any settlement proposal and a summary of any unsettled issues in the case. OEB staff will, at the direction of the OEB, confirm or amend this date in subsequent correspondence.

All materials filed with the OEB must quote the file number, **EB-2020-0048**, be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice>. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <https://www.oeb.ca/industry>.
