Re: Temporary Reporting Requirement Related to Impact Assessment of Global Adjustment Deferrals for non-RPP Class B Customers

On May 15, 2020, the OEB provided <u>guidance</u> to electricity distributors regarding the implementation of the May 1, 2020 Emergency Order under which a portion of the Global Adjustment (GA) was deferred for Class A customers and Class B customers that are not on the Regulated Price Plan (RPP). The purpose of this letter is to set out a temporary reporting requirement related to the implementation of the GA deferral.

The guidance noted that the charge type 148 credit for the GA deferral for non-RPP Class B customers is derived in part from the RPP consumption information submitted by distributors as part of the RPP settlement process. It further indicated that the current settlement submission process does not allow for separate reporting of non-RPP Class B consumption true-ups and as a result, charge type 148 credit for the GA deferral will not be trued-up. The guidance stated that the OEB will communicate the process to true-up the charge type 148 credit should a need for a true-up be determined.

This temporary reporting requirement has been developed to enable the OEB to assess the impact of using estimated volumes in calculating the GA deferral for non-RPP Class B customers and whether a true-up would be required.

A description of the temporary reporting requirement is provided in Appendix A. An <a href="mailto:excel worksheet">excel worksheet</a> has been provided in Appendix B to be used for this reporting and will also be posted on the OEB's website under <a href="mailto:Reporting-and-Record-keeping">Reporting-and Record-keeping</a> Requirements.

This reporting requirement is being issued under section 14 of the distributor licences which requires entities to provide such information as the OEB may require from time to time.

Distributors are required to submit this report to <u>performance\_reporting@oeb.ca</u> by October 29<sup>th</sup>, 2020.
