



Enbridge Gas Inc.

**Application for leave to construct natural gas pipeline
and ancillary facilities in the City of Toronto**

**PROCEDURAL ORDER NO. 2
October 8, 2020**

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on July 31, 2020, under sections 90 and 97 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), for an order granting leave to construct approximately 4.5 kilometres of natural gas pipeline and ancillary facilities in the City of Toronto. The proposed pipeline will replace approximately 4.3 kilometres of pipeline along Lake Shore Boulevard between Cherry Street to Bathurst Street and approximately 230 metres of pipeline on Parliament Street. Enbridge Gas has also applied for approval of the form of land-use agreements it offers to landowners for the routing and construction of the project.

On August 21, 2020, the OEB issued a Notice of Hearing, which provided for interested participants to apply for intervenor status and cost eligibility in the proceeding. In its Procedural Order No.1 (P.O. No.1), the OEB, among other things, set out a schedule for interrogatories and responses to interrogatories.

By letter dated October 6, 2020, Enbridge Gas requested an extension of the October 13, 2020, deadline for filing interrogatory responses to October 21, 2020. Enbridge Gas cited complexities of employees working remotely in response to the COVID-19 pandemic and the large number of interrogatories, in making its request. Enbridge Gas noted that is committed to ensuring that the responses will be filed by the new deadline.

Based on the reasons provided, the OEB grants Enbridge Gas an extension to the deadline for filing interrogatory responses. The OEB reminds parties that requests for extensions to the case schedule may result in delays in the final decision on the application.

The deadline in item 2 of P.O. No.1 is revised accordingly as shown below.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. Enbridge Gas shall file with the OEB complete written responses to all interrogatories and serve them on intervenors by **October 21, 2020**.

All filings to the OEB must quote the file number, **EB-2020-0136**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice/>. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.ca/industry. If the web portal is not available parties may email their documents to registrar@oeb.ca.
