The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Enbridge Gas Inc.'s 2021 Federal Carbon Pricing Program application (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 and 2 below **prior to October 24, 2020**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at Registrar@oeb.ca.

You are directed:

1. No later than the date the Notice is posted on Enbridge Gas Inc.'s website in accordance with paragraph 2, to:
 - a) arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application and the evidence, directly on
 - i. The clerks of all municipalities in which Enbridge Gas Inc. supplies gas
 - ii. The band councils of all Indigenous communities and First Nation Reserves to which Enbridge Gas Inc. supplies gas
 - iii. The Métis Nation of Ontario
 - iv. Intervenors in Enbridge Gas Inc.'s 2020 Federal Carbon Pricing Program proceeding, EB-2019-0247
 - v. Intervenors in Enbridge Gas Inc.'s 2021 Rates proceeding, EB-2020-0095
 - vi. The Ontario Ministry of Energy, Northern Development and Mines

- vii. The Ontario Ministry of the Environment, Conservation and Parks
 - viii. Environment and Climate Change Canada
 - ix. The Canada Revenue Agency
2. To make a copy of the Notice, the application and evidence, and any amendments thereto, available for public review at Enbridge Gas Inc.'s office and in a prominent place on Enbridge Gas Inc.'s website.
 3. To file with the OEB an affidavit proving completion of the matters in paragraphs 1 and 2 above immediately thereafter.
 4. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
