

Enbridge Gas Inc.

**Application for leave to construct natural gas pipeline and
ancillary facilities in the City of Toronto**

**PROCEDURAL ORDER NO. 3
October 27, 2020**

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on July 31, 2020, under sections 90 and 97 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), for an order granting leave to construct approximately 4.5 kilometres of natural gas pipeline and ancillary facilities in the City of Toronto. The proposed pipeline will replace approximately 4.3 kilometres of pipeline along Lake Shore Boulevard between Cherry Street to Bathurst Street and approximately 230 metres of pipeline on Parliament Street. Enbridge Gas has also applied for approval of the form of the land-use agreement it will offer to landowners for the routing and construction of the project.

On August 21, 2020, the OEB issued a Notice of Hearing, which provided for interested participants to apply for intervenor status and cost eligibility in the proceeding. In its Procedural Order No.1, issued on September 21, 2020, the OEB, among other things, set out a schedule for interrogatories and responses to interrogatories.

On October 8, 2020, the OEB issued Procedural Order No. 2, which granted Enbridge Gas's request for an extension to the deadline to file interrogatory responses. Enbridge Gas filed its responses to interrogatories on October 21, 2020. This Procedural Order schedules the subsequent procedural steps in the proceeding.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. Enbridge Gas shall file with the OEB its Argument-in-Chief and serve it on all parties by **November 2, 2020**.

2. Any written submissions from OEB staff and intervenors shall be filed with the OEB and served on all parties by **November 9, 2020**.
3. Any written reply submissions from Enbridge Gas shall be filed with the OEB and served on intervenors by **November 17, 2020**.

All materials filed with the OEB must quote the file number, **EB-2020-0136**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice>. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the [Regulatory Electronic Submission System \(RESS\) Document Guidelines](#) found at www.oeb.ca/industry.
