



**EPCOR Natural Gas Limited Partnership**

**Application for natural gas distribution rates and other  
charges effective January 1, 2021**

**PROCEDURAL ORDER NO. 1  
November 11, 2020**

EPCOR Natural Gas Limited Partnership (ENGLP) filed an incentive rate-setting mechanism (IRM) application with the Ontario Energy Board (OEB) on October 8, 2020 under section 36 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to its natural gas distribution rates to be effective January 1, 2021.

A Notice of Hearing was issued on October 22, 2020. No persons applied for intervenor status.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

**IT IS THEREFORE ORDERED THAT:**

1. OEB staff shall request any relevant information and documentation from ENGLP that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on ENGLP by **November 20, 2020**.
2. ENGLP shall file with the OEB complete written responses to the interrogatories by **December 4, 2020**.
3. Any written submissions by OEB staff shall be filed with the OEB and served on ENGLP by **December 18, 2020**.
4. If ENGLP wishes to file a reply submission, it must file its written reply submission with the OEB by **January 5, 2021**.

Parties are responsible for ensuring that any documents they file with the OEB do not include personal information (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*

All materials filed with the OEB must quote the file number, **EB-2020-0234**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <https://pes.ontarioenergyboard.ca/eservice>. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address.
