



Enbridge Gas Inc.

Integrated Resource Planning Proposal

PROCEDURAL ORDER NO. 6 November 18, 2020

Enbridge Gas Inc. (Enbridge Gas) originally submitted an Integrated Resource Planning (IRP) Proposal to the OEB on November 1, 2019 as part of its Dawn-Parkway System Expansion Project Application (EB-2019-0159). As part of that Application, Enbridge Gas requested that the OEB determine that its IRP Proposal is reasonable and appropriate, both in relation to the Dawn-Parkway System Expansion Project, and for application to future Enbridge Gas projects. On April 28, 2020, the OEB issued a Notice of Hearing, that initiated a review of Enbridge Gas' IRP Proposal as a separate proceeding (EB-2020-0091).

On July 15, 2020, the OEB issued a Decision on Issues List and Procedural Order No. 2 that, among other things, provided steps for parties who intended to file evidence in this proceeding.

On August 20, 2020, the OEB issued Procedural Order No. 4 that accepted the proposals to file evidence submitted by Enbridge Gas, OEB staff and Green Energy Coalition (GEC)/Environmental Defence (ED). Procedural Order No. 4 set dates for these parties to file evidence, including a filing date of November 19, 2020 for the evidence to be submitted by GEC/ED.

On November 9, 2020, Pollution Probe filed a letter of comment, indicating that it had concerns that there may be gaps in the evidence and information that the OEB will need to make an informed decision based on best available information in this proceeding. Pollution Probe requested that the OEB consider additional procedural options to address this concern as it considered next steps in this proceeding.

On November 17, 2020, GEC/ED filed a request for a brief extension of its deadline to file evidence, to Monday, November 23, 2020.

Next Steps

The OEB grants GEC/ED's request for an extension. Accordingly the date provided in Procedural Order No. 4 for GEC/ED's filing of evidence is superseded by the date below.

The dates previously established for Enbridge Gas to notify the OEB if it will not be filing responding evidence, and to file responding evidence, if necessary, remain unchanged. The OEB intends to provide further details regarding next steps in this proceeding after GEC/ED has filed its evidence and once it is known whether Enbridge Gas will file responding evidence, and will consider Pollution Probe's comments at that time.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. Environmental Defence/Green Energy Coalition shall file its evidence with the OEB by **November 23, 2020**.

All materials filed with the OEB must quote the file number, **EB-2020-0091**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at https://pes.ontarioenergyboard.ca/eservice. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the Regulatory Electronic Submission System (RESS) Document Guidelines found at www.oeb.ca/industry. We encourage the use of RESS; however, parties who have not yet set up an account, may email their documents to registrar@oeb.ca.
