Overview

1. BOMA has reviewed and supports the submissions of SEC. BOMA has no further submissions.

Background

- 2. On August 31, 2020, Hydro One Networks Inc. (Hydro One) filed an annual rate update application with the Ontario Energy Board (OEB) on August 31, 2020 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) seeking approval for changes to its electricity distribution rates to be effective January 1, 2021.
- 3. On October 7, 2020, BOMA applied for intervenor status and cost award eligibility in this proceeding.
- 4. On October 9, 2020, the OEB issued Procedural Order No. 1 in this proceeding. As part of that order, the OEB granted BOMA's application for intervenor status and cost award eligibility and established October 19, 2020 as the date by which written interrogatories were to be served and filed, October 26, 2020 as the date by which written responses to the interrogatories were to be served and filed, November 13, 2020 as the date by which Intervenors and OEB staff shall serve and file any written submissions and November 23, 2020 as the date by which Hydro One shall serve and file its written reply submissions.
- 5. BOMA did not serve and file interrogatories.

6. On October 22, 2020, Hydro One filed a letter with the OEB requesting a four day

extension for the filing of its interrogatory responses and other related changes to the

schedule established in Procedural Order No. 1.

7. On October 23, 2020, the OEB granted Hydro One's request and revised the date by

which written responses to the interrogatories were to be served and filed to October 30,

2020, the date by which Intervenors and OEB staff shall serve and file any written

submissions to November 18, 2020 and the date by which Hydro One shall serve and file

its written reply submissions to November 24, 2020.

8. On November 18, 2020, BOMA reviewed the submissions of SEC in this proceeding.
