Pursuant to the Board's Notice of Application dated September 7, 2006 in this matter, please find TransCanada Energy Ltd.'s ("TCE") Late Intervention in this matter. TCE, in partnership with Ontario Power Generation, has recently executed a Power Purchase Agreement for the Portlands Energy Centre ("PEC") with the Ontario Power Authority.
