Re: EB-2020-0057 Toronto Hydro-Electric System Limited Application for 2021 Rates

Ted Antonopoulos, the Ontario Energy Board's Vice-President of Applications has been delegated authority under Section 6 of the *Ontario Energy Board Act, 1998* to make a decision on the 2021 Price Cap IR application filed by Toronto Hydro-Electric System Limited (Toronto Hydro) on August 24, 2020.

Attached to this letter is a draft of the decision the delegated authority proposes to make based on the application and any subsequent updates or clarifications. As Toronto Hydro is using its own version of the Rate Generator model, and associated models and spreadsheets, to accommodate the unique features of its approved Custom Incentive Rate-setting plan for 2020-2024,¹ you are requested to provide any necessary updates to the Rate Generator model, associated spreadsheets, bill impact calculations, and a draft Tariff of Rates and Charges, reflecting any changes per your comments, Toronto Hydro's letter of November 9, 2020 on the inflation factor it has elected for 2021, and other updates to the application evidence during processing.

Please review the decision and the accompanying draft Rate Order for accuracy and completeness. Provide written comments or a confirmation that Toronto Hydro has no comments no later than December 2, 2020.
