ENTEGRUS POWERLINES INC.

Application for rates and other charges for Entegrus - St. Thomas rate zone to be effective January 1, 2021, and for Entegrus - Main rate zone to be effective May 1, 2021

1 INTRODUCTION AND SUMMARY

Through this Decision and Rate Order, the Ontario Energy Board (OEB) approves the incentive rate-setting mechanism (IRM) application filed by Entegrus Powerlines Inc. (Entegrus Powerlines) for new rates effective January 1, 2021 for the St. Thomas rate zone, and May 1, 2021 for the Main rate zone.

On July 21, 2017, Entegrus Powerlines and St. Thomas Energy Inc. (St. Thomas Energy) submitted a merger, amalgamation, acquisition and divestiture (MAADs) application seeking approval to amalgamate and continue as Entegrus Powerlines. On March 15, 2018, the OEB approved the amalgamation and deferred rate re-basing for the merged entity to 2026. Subsequently, Entegrus Powerlines notified the OEB that the transaction was complete effective April 1, 2018. On April 19, 2018, Entegrus Powerlines received its amended License. 2

As noted in the MAADs application, Entegrus Powerlines plans to maintain two separate rate zones until such time as rates are re-based.

Entegrus Powerlines serves approximately 59,000 mostly residential and commercial electricity customers in the Municipality of Chatham-Kent, the Towns of Strathroy and Parkhill, the Villages of Mount Brydges, Dutton and Newbury and the City of St. Thomas. The company is seeking the OEB's approval for the rates it charges to distribute electricity to its customers, as is required of licensed and rate-regulated distributors in Ontario.

A distributor may choose one of three rate-setting methodologies approved by the OEB. Each of these is explained in the *Handbook for Utility Rate Applications*.

Entegrus Powerlines' application is for both rate zones and is based on a Price Cap Incentive Rate-setting option (Price Cap IR), with a five-year term. The Price Cap IR option involves the setting of rates through a cost of service application in the first year. Mechanistic price cap adjustments, based on inflation and the OEB's assessment of the distributor's efficiency, are typically then approved through IRM applications in each of the ensuing four (adjustment) years.

As a result of this Decision, there will be a monthly total bill increase of \$0.66 in the Entegrus - Main rate zone effective May 1, 2021, and an increase of \$2.28 in the Entegrus - St. Thomas rate zone effective January 1, 2021, for a residential customer

consuming 750 kWh. The increases do not factor in applicable taxes or the Ontario Electricity Rebate. $^{\rm 3}$

2 THE PROCESS

This Decision is being issued by delegated authority, without a hearing, under section 6 of the *Ontario Energy Board Act*, 1998 (the OEB Act).

The OEB follows a standardized and streamlined process for hearing IRM applications filed under Price Cap IR. In each adjustment year of a Price Cap IR term, the OEB prepares a Rate Generator Model that includes, as a placeholder, information from the distributor's past proceedings and annual reporting requirements.⁴ A distributor will then review and complete the Rate Generator Model, and include it with its application.

Entegrus Powerlines filed its application on August 17, 2020 under section 78 of the OEB Act and in accordance with the Chapter 3 of the OEB's <u>Filing Requirements for Incentive Rate-Setting Applications</u> (Filing Requirements).

The application was supported by pre-filed written evidence and a completed Rate Generator Model. During the course of the proceeding, the applicant responded to OEB staff questions through emails and phone calls and, where required, updated and clarified the evidence.

3 ORGANIZATION OF THE DECISION

In this Decision, the OEB addresses the following issues, and provides reasons for approving or denying Entegrus Powerlines' proposals relating to each of them:

- Price Cap Adjustment
- Retail Transmission Service Rates
- Group 1 Deferral and Variance Accounts
- Lost Revenue Adjustment Mechanism Variance Account Balance

In the final section, the OEB addresses the steps to implement the final rates that flow from this Decision.

This Decision does not address rates and charges approved by the OEB in previous proceedings, which are not part of the scope of an IRM proceeding (such as specific service charges⁵ and loss factors). No further approvals are required to continue to include these items on a distributor's Tariff of Rates and Charges.

4 PRICE CAP ADJUSTMENT

Entegrus Powerlines seeks to increase its rates based on a mechanistic rate adjustment using the OEB-approved *inflation minus X-factor* formula applicable to Price Cap IR applications.

The components of the Price Cap IR adjustment formula applicable to Entegrus Powerlines are set out in Table 4.1, below. Inserting these components into the formula results in a 2.05% increase to Entegrus Powerlines' rates: **2.05% = 2.20% -** (0.00% + **0.15%)**.

A maximum inflation factor of 2.20% applies to all Price Cap IR applications for the 2021 rate year, provided that a utility does not elect a lower inflation factor to be used.

The X-factor is the sum of the productivity factor and the stretch factor. It is a productivity offset that will vary among different groupings of distributors. Subtracting the X-factor from inflation ensures that rates decline in real, constant-dollar terms, providing distributors with a tangible incentive to improve efficiency or else experience declining net income.

The productivity component of the X-factor is based on industry conditions over a historical study period and applies to all Price Cap IR and Annual IR Index applications for the 2021 rate year.

The stretch factor component of the X-factor is distributor specific. The OEB has established five stretch factor groupings, each within a range from 0.00% to 0.60%. The stretch factor assigned to any particular distributor is based on the distributor's total cost performance as benchmarked against other distributors in Ontario. The most efficient distributor would be assigned the lowest stretch factor of 0.00%. Conversely, a higher stretch factor would be applied to a less efficient distributor (in accordance with its cost performance relative to expected levels) to reflect the incremental productivity gains that the distributor is expected to achieve. The stretch factor assigned to Entegrus Powerlines is 0.15%.

In light of the continued uncertainty regarding the severity and duration of the COVID-19 emergency, and its impact on electricity utilities and customers alike, for 2021 rate adjustment applications, the OEB allowed utilities the discretion of applying either the calculated inflation factor in accordance with the OEB-approved methodology or a lower value. Utilities were also given the discretion to forego the inflationary increase entirely.⁹

The OEB required all utilities that filed (or were planning to file) 2021 rate adjustment applications to file a letter on the record of their rates proceedings, indicating the inflation factor that the utility has elected.

On November 19, 2020, Entegrus Powerlines filed a letter advising the OEB that it is electing an inflation factor of 2.2 % for 2021 rates for each of the Main rate zone and St. Thomas rate zone, resulting in a rate adjustment of 2.05%.¹⁰

Findings

The OEB finds that Entegrus Powerlines' request for a 2.05% rate adjustment is in accordance with the annually updated parameters set by the OEB, as well as the process established for the implementation of the 2021 inflation factor in light of the COVID-19 pandemic. The adjustment is approved, and Entegrus Powerlines' new rates for the Main rate zone shall be effective May 1, 2021 and for the St. Thomas rate zone shall be effective January 1, 2021.

The adjustment applies to distribution rates (fixed and variable) uniformly across all customer classes.¹¹

5 RETAIL TRANSMISSION SERVICE RATES

Distributors charge retail transmission service rates (RTSRs) to their customers in order to recover the amounts they pay to a transmitter, a host distributor, or both, for transmission services. All transmitters charge Uniform Transmission Rates (UTRs) to distributors connected to the transmission system. Host distributors charge host-RTSRs to distributors embedded within the host's distribution system. Each of these rates is OEB-approved.

The Entegrus - Main rate zone is partially embedded within Hydro One Networks Inc.'s distribution system. Entegrus Powerlines is requesting approval to adjust the RTSRs that the Entegrus - Main rate zone charges its customers to reflect the currently approved rates that it pays for transmission services included in Table 5.1 and Table 5.2.

The Entegrus - St. Thomas rate zone is transmission connected. Entegrus Powerlines is requesting approval to adjust the RTSRs that the Entegrus - St. Thomas rate zone charges its customers to reflect the rates that it pays for transmission services included in Table 5.1 below.

Findings

Entegrus Powerlines' proposed adjustment to its RTSRs for both rate zones is approved. Entegrus Powerlines' RTSRs were adjusted to reflect the OEB-approved interim 2020 UTRs and 2020 host-RTSRs (for the Entegrus - Main rate zone), and for the interim 2020 UTRs (for the Entegrus - St. Thomas rate zone).

The OEB finds that the interim 2020 UTRs and Hydro One Networks Inc.'s 2020 host sub-transmission RTSRs were incorporated into the rate model to adjust the RTSRs that Entegrus Powerlines will charge its customers.

The differences resulting from the approval of final 2020 UTRs, as well as from the approval of new 2021 UTRs and new 2021 RTSRs for Hydro One Networks Inc. will be captured in Accounts RSVA - Retail Transmission Network Charge 1584 and Retail Transmission Connection Charge 1586.

6 GROUP 1 DEFERRAL AND VARIANCE ACCOUNTS

In each year of an IRM term, the OEB will review a distributor's Group 1 deferral and variance accounts (DVA) in order to determine whether their total balance should be disposed. OEB policy requires that Group 1 accounts be disposed if they exceed (as a debit or credit) a pre-set disposition threshold of \$0.001 per kWh, unless a distributor justifies why balances should not be disposed. If the balance does not exceed the threshold, a distributor may elect to request disposition.

(I) Entegrus - Main rate zone

The 2019 actual year-end total balance for Entegrus - Main rate zone's Group 1 accounts, including interest projected to April 30, 2021 is a debit of \$1,046,447. This amount represents a total debit claim of \$0.0012 per kWh, which exceeds the disposition threshold, and the utility has requested disposition of this debit amount over a one-year period.

a) Global Adjustment Variance Account

One of the components of the commodity costs billed by the Independent Electricity System Operator (IESO), which is included in Group 1 accounts, is the Global Adjustment (GA).¹⁶

Different customer groups pay the GA in different ways:

- For Regulated Price Plan (RPP) customers, the GA is incorporated into the standard commodity rates customers pay. Therefore, there is no separate variance account for the GA.
- "Class A" customers are allocated GA costs based on the percentage their demand contributes to the top five Ontario system peaks. As distributors settle with Class A customers based on actual GA costs, there is no resulting variance.

payments for building or refurbishing infrastructure such as gas-fired and renewable facilities and other nuclear

contracted rates paid to a number of generators across the province

[•] the cost of delivering conservation programs.

"Class B" non-RPP customers are billed GA based on the electricity they
consume in a month at the IESO published GA price. Distributors track any
difference between the billed amounts and actual costs for these customers in
the GA Variance Account for disposal, once audited.

Under the general principle of cost causality, customer groups that cause variances which are recorded in Group 1 accounts should be responsible for paying (or receiving credits) for their disposal. A customer's movement from one group to another should not prevent that customer from paying/receiving a debit/credit balance.

The applicant proposes, for the Entegrus - Main rate zone, the recovery of its GA variance account balance of \$588,007 as at December 31, 2019, including interest to April 30, 2021, in accordance with the following table.

b) Capacity Based Recovery Class B Sub-account

The balance of the Group 1 accounts includes the Capacity Based Recovery (CBR) sub-account for Class B customers of \$57,863, relating to the IESO's wholesale energy market for the CBR program. The Entegrus - Main rate zone had Class A customers during the period from January 2019 to December 2019 so it applied to have the balance of this account disposed through a separate kWh rate rider for Class B customers in order to ensure proper allocation between Class A and Class B customers.

As some customers were reclassified between Class A and Class B during the period from January 2019 to December 2019, Entegrus Powerlines requested refund of a portion of CBR Class B costs by way of 12 equal installments.¹⁸

c) Group 1 Accounts

The Group 1 accounts being sought for disposition (excluding GA) include the following flow through variance accounts: Low Voltage Charges, Smart Meter Entity Charges, Wholesale Market Service Charges, Retail Transmission Service Charges, and Commodity Power Charges. These Group 1 accounts have a total debit balance of \$458,440, which results in a charge to customers. This balance combined with the balance for the GA account results in the total debit balance for Group 1 accounts of \$1,046,447.

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements.*¹⁹ The applicant further submits that, for the Entegrus - Main rate zone, its proposal for a one-year disposition period is in accordance with the OEB's policy.²⁰

In its 2020 rate application, Entegrus Powerlines received approval, for the Entegrus - Main rate zone, to dispose of 2018 Group 1 balances on a final basis. Entegrus Powerlines has reviewed the 2019 balances in the context of the new accounting guidance and as a result has requested final disposition of its 2019 balances for the Entegrus - Main rate zone.

Findings

The OEB approves the disposition of a debit balance of \$1,046,447 as of December 31, 2019, including interest projected to April 30, 2021, for Group 1 accounts on a final basis.

The following table identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*.²¹ The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. Entegrus Powerlines shall ensure these adjustments are included in the reporting period ending June 30, 2021 (Quarter 2).

The OEB approves these balances to be disposed through final rate riders, charges/payments as calculated in the Rate Generator Model. The final rate riders, charges/payments will be in effect over a one-year period from May 1, 2021 to April 30, 2022.²²

(II) Entegrus - St. Thomas rate zone

The 2019 actual year-end total balance for Entegrus - St. Thomas rate zone's Group 1 accounts, including interest projected to December 31, 2020, is a credit of \$12,095. This amount represents a total debit claim of \$0.00004 per kWh, which does not exceed the disposition threshold. Entegrus Powerlines has requested disposition of this credit amount over a one-year period. In its application, Entegrus Powerlines noted the rate riders for all rate classes round to appropriate decimal levels and that disposing of Group 1 accounts below the threshold aligns practices between rate zones and ensures causality clarity for customers.²³

a) Global Adjustment Variance Account

The applicant proposes, for the Entegrus - St. Thomas rate zone, the recovery of its GA variance account balance of \$57,767 as at December 31, 2019, including interest to December 31, 2020, in accordance with the following table.

b) Capacity Based Recovery Class B Sub-account

The balance of the Group 1 accounts includes the Capacity Based Recovery (CBR) sub-account for Class B customers of \$17,578, relating to the IESO's wholesale energy market for the CBR program. The Entegrus - St. Thomas rate zone had Class A customers during the period from January 2019 to December 2019 so it applied to have the balance of this account disposed through a separate kWh rate rider for Class B

customers in order to ensure proper allocation between Class A and Class B customers.

c) Group 1 Accounts

The Group 1 accounts being sought for disposition (excluding GA) include the following flow through variance accounts: Smart Meter Entity Charges, Wholesale Market Service Charges, Retail Transmission Service Charges, and Commodity Power Charges. These Group 1 accounts have a total credit balance of \$69,863, which results in a refund to customers. This balance combined with the balance for the GA account results in the total credit balance for Group 1 accounts of \$12,095.

The balances proposed for disposition reconcile with the amounts reported as part of the OEB's *Electricity Reporting and Record-Keeping Requirements*.²⁴ The applicant further submits that, for the Entegrus - St. Thomas rate zone, its proposal for a one-year disposition period is in accordance with the OEB's policy.²⁵

In its 2020 rate application, Entegrus Powerlines received approval, for the Entegrus - St. Thomas rate zone, to dispose of 2018 Group 1 balances on a final basis. Entegrus Powerlines has reviewed the 2019 balances in the context of the new accounting guidance and as a result has requested final disposition of its 2019 balances for the Entegrus - St. Thomas rate zone.

Findings

The OEB approves the disposition of a credit balance of \$12,095 as of December 31, 2019, including interest projected to December 31, 2020, for Group 1 accounts on a final basis.

The following table identifies the principal and interest amounts, which the OEB approves for disposition.

The balance of each of the Group 1 accounts approved for disposition shall be transferred to the applicable principal and interest carrying charge sub-accounts of Account 1595. Such transfer shall be pursuant to the requirements specified in Article 220, Account Descriptions, of the *Accounting Procedures Handbook for Electricity Distributors*. ²⁶ The date of the transfer must be the same as the effective date for the associated rates, which is, generally, the start of the rate year. Entegrus Powerlines shall ensure these adjustments are included in the reporting period ending March 31, 2021 (Quarter 1).

The OEB approves these balances to be disposed through final rate riders as calculated in the Rate Generator Model. The final rate riders will be in effect over a one-year period from January 1, 2021 to December 31, 2021.²⁷

7 LOST REVENUE ADJUSTMENT MECHANISM VARIANCE ACCOUNT BALANCE

A distributor's conservation and demand management (CDM) programs may result in reduced overall consumption. To address this, the OEB utilizes a Lost Revenue Adjustment Mechanism Variance Account (LRAMVA), which captures a distributor's revenue implications resulting from differences between actual savings and forecast conservation savings included in the last OEB-approved load forecast.²⁸ These differences are recorded by distributors at the rate class level.

Beginning on January 1, 2015, distributors delivered CDM programs to their customers through the Conservation First Framework (CFF). On March 20, 2019, the CFF was revoked.²⁹ Shortly thereafter, the OEB advised that electricity distributors would continue to have access to a lost revenue adjustment mechanism for conservation program activities undertaken under the CFF.³⁰ The OEB provided direction to distributors seeking to claim program savings up to December 31, 2019 related to CFF programs or other programs they deliver.³¹

A distributor may apply for the disposition of the balance in the LRAMVA on an annual basis, as part of its IRM application, if the balance is deemed significant by the distributor.

Entegrus Powerlines has applied to dispose of its LRAMVA debit balances of \$348,126 for the Main rate zone and \$71,597 for the St. Thomas rate zone. The balance consists of lost revenues in 2018 from CDM programs delivered during the period from 2014 to 2018 as well as associated carrying charges.

In response to OEB staff questions, Entegrus Powerlines revised the LRAMVA balance for the St. Thomas rate zone to remove the savings threshold for the Sentinel lighting rate class. There were no changes to the Main rate zone's LRAMVA balance in response to OEB staff questions. This update resulted in an increase of \$192 and a revised combined LRAMVA balance of \$419,723. The actual conservation savings claimed by Entegrus Powerlines under the CFF were determined by the IESO.³² For

CDM programs delivered prior to 2018, the IESO provided LDCs with a Final Verified Results Report that summarized all annual CDM results. For CDM programs delivered in 2018 and until the end of the CFF in 2019, the IESO made monthly Participation and Cost Reports and detailed project level data available to Entegrus Powerlines.

Actual conservation savings were compared against Entegrus Powerlines' forecasted conservation savings of 11,206,240 kWh included in the load forecast, which was set out in Entegrus Powerlines' 2016 cost of service proceeding and St. Thomas Energy Inc.'s 2015 cost of service proceeding.³³

Findings

The OEB finds that Entegrus Powerlines' LRAMVA balances for its Main rate zone and its St. Thomas rate zone have been calculated in accordance with the OEB's CDM-related guidelines and updated LRAMVA policy. The OEB approves the disposition of Entegrus Powerlines' LRAMVA debit balance of \$419,723, as set out in Table 7.1.

8 IMPLEMENTATION AND ORDER

This Decision is accompanied by a Rate Generator Model, applicable supporting models, and a Tariff of Rates and Charges (Schedule A).

Model entries were reviewed in order to ensure that they are in accordance with each of Entegrus Powerlines' and St. Thomas Energy Inc.'s last cost of service decision, and to ensure that the 2020 OEB-approved Tariff of Rates and Charges, as well as the cost, revenue and consumption results from 2019, are as reported by Entegrus Powerlines to the OEB.

The Rate Generator Model was adjusted, where applicable, to correct any discrepancies. The Rate Generator Model incorporates the rates set out in the following table.
