Application for 2021 Rates**

Pascale Duguay, the Ontario Energy Board's Manager of Applications, Natural Gas has been delegated authority under Section 6 of the *Ontario Energy Board Act, 1998* to make a decision on the 2021 Price Cap IR application filed by Lakefront Utilities Inc. on August 17, 2020.
