#### **EPCOR Natural Gas Limited Partnership**

# Application to amend the certificate of public convenience and necessity for the Township of South-West Oxford

# PROCEDURAL ORDER NO. 1 December 8, 2020

EPCOR Natural Gas Limited Partnership (ENGLP) filed an application with the Ontario Energy Board (OEB) on October 29, 2020 under section 8 of the *Municipal Franchises Act*. The application is for an order amending ENGLP's certificate of public convenience and necessity (certificate) related to the Township of South-West Oxford to include areas around Mount Elgin Road and McBeth Road.

A Notice of Hearing was issued on November 11, 2020. Enbridge Gas Inc. (Enbridge Gas) applied for intervenor status. No objection was received from ENGLP.

Enbridge Gas is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

#### IT IS THEREFORE ORDERED THAT:

- OEB staff and Enbridge Gas shall request any relevant information and documentation from ENGLP that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties, by **December** 15, 2020.
- 2. ENGLP shall file with the OEB complete written responses to all interrogatories and serve them on all parties by **December 22, 2020**.
- 3. OEB staff and Enbridge Gas may file any written submission with the OEB and serve it on all parties by **January 12, 2021**.

4. ENGLP may file a written reply submission with the OEB and serve it on all parties by **January 19, 2021**.

All materials filed with the OEB must quote the file number, **EB-2020-0232**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <a href="https://pes.ontarioenergyboard.ca/eservice">https://pes.ontarioenergyboard.ca/eservice</a>. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the <a href="Regulatory Electronic Submission System">Regulatory Electronic Submission System</a> (RESS) Document <a href="Guidelines">Guidelines</a> found at <a href="www.oeb.ca/industry">www.oeb.ca/industry</a>. We encourage the use of RESS; however, parties who have not yet <a href="mailto:set up an account">set up an account</a>, may email their documents to registrar@oeb.ca.
