The Project is an approximately 450 kilometer, double-circuit, 230-kilovolt transmission line from the Wawa Transformer Station (TS) to the Lakehead TS in the Municipality of Shuniah, near Thunder Bay, Ontario, with a connection approximately mid-way at the Marathon TS.

Construction of the project began in September 2019 and is expected to be complete by the end of 2021.

COVID-19 Response

Project Map and Construction Timing



Project construction is divided into 11 workfronts. Construction will generally begin at the west end of workfronts 1 and 7 and progress in an easterly direction. Four worker camps are also anticipated for the project to house construction staff. Construction began on workfront 1 the week of September 23, 2019. Construction will commence in other workfronts as permits are acquired. The current anticipated construction schedule is shown below. Given the complexity of the project, this schedule may change, and any updates will be posted here.

November 2019	Workfront 7
December 2019	Workfronts 2, 4, 5, 6, 8, 10, and 11

How do you build a transmission line? The Construction Process

Construction of a high-voltage transmission line is similar to highway construction. It moves forward in phases and involves moving along the corridor as construction progresses. During construction in your community, you can expect to see the following steps take place.

- STEP 1 Right of Way Clearing and Access Road Construction**

 - May consist of logging, mulching and clearing of debris
- STEP 2 Geomatics & Surveys**

 - Survey crews stake or flag locations for the towers using predetermined GPS coordinates
 - Crews also determine if the planned tower location is actually viable for installation

STEP 3 Material Delivery

- Materials are stored and sorted in material yards offsite and will be delivered to site as they are required

STEP 4 Foundations and Anchors for Two Types of Towers

- Self-Supporting Towers – require foundations for each leg of the towers
- Guyed-Y Towers – require one foundation and multiple anchors for the guy wires

STEP 5 Tower Assembly

- Steel towers are typically assembled on the ground or in a laydown yard near each tower site

STEP 6 Tower Erection

- Towers are set into place with cranes or helicopters
- Some towers are erected as one piece, while others are done in multiple pieces
- Towers are then secured to the foundation

STEP 7 Conductor Stringing

- Stringing refers to hanging and fastening the conductor wire to the towers, this can be done with cranes or helicopters

STEP 8 Reclamation

- After completing construction in an area, the sites will be returned as close as possible to their original ground conditions

Safety is our Top Priority – How do you stay safe during construction?

At NextBridge, the safety of community members, our employees and the environment is our top priority so we must all work together to prevent injury. For your safety and that of workers, during construction please:

- Respect all speed and direction signs in construction zones
- Obey signs and instructions provided by flag people
- Watch out for increased construction vehicle activity on local roads and highways
- Obey signs at construction sites, including “no trespassing” signs on the rights of way and at laydown yards
- Respect temporary road and trail closures
