On December 10, 2020, the Ontario Energy Board (OEB) announced that it was initiating a review of the regional planning process that applies to Ontario's electricity sector and invited stakeholders to volunteer to participate on a newly constituted Regional Planning Process Advisory Group (RPPAG).
