Dear Ms. Long:

Re: EB-2020-0284: Bruce Power L.P. (Bruce Power) Leave to Construct (LTC) a Proposed Pipeline.

The Board issued a *Decision and Order* in the captioned matter on December 17th, 2020, granting leave to construct a proposed hydrocarbon pipeline and ancillary facilities (Pipeline) to Bruce Power. The Board's approval includes a number of conditions. One of those conditions is that Bruce Power designate one of its employees as a project manager who will be the point of contact for fulfillment of the conditions, and that Bruce Power provide the designated employee's name and contact information to the OEB and to all affected landowners, and clearly post the project manager's contact information in a prominent place at the construction site.

Bruce Power has designated Nancy Green, Bruce Power Division Manager Site Services, as project manager for the Pipeline. Ms. Green's contact information is as follows:

A copy of this letter of notification will be provided to affected/interested landowners, being the other three parties with operations at the Bruce Nuclear Power Development (Ontario Power Generation (the owner of the site), Canadian Nuclear Laboratories and Hydro One), and the indigenous stakeholders with whom Bruce Power has regular engagement (the Saugeen Ojibway Nation (SON), the Historic Saugeen Métis and the Métis Nation of Ontario). When construction of the Pipeline begins Bruce Power will also post Ms. Green's contact information, as set out above, in a prominent place at the construction site.
