Re: Regional Planning Process Review (EB-2020-0176)

The OEB is pleased to share with stakeholders further information about the newly constituted Regional Planning Process Advisory Group (RPPAG), it's membership, scope of work and to address matters related to cost eligibility.

On December 10, 2020, the Ontario Energy Board (OEB) issued a <u>letter</u> (December 10<sup>th</sup> letter) that initiated a consultation to undertake a review of the regional planning process that applies to Ontario's electricity sector. The December 10<sup>th</sup> letter indicated that the first step in this consultation involved re-establishing the RPPAG to assist the OEB in this review and that the initial RPPAG meeting would be held in February 2021.

## Scope

The objective for the RPPAG is to provide a set of recommendations related to potential changes to the regional planning process for consideration by the OEB which may result in both proposed changes to the current regional planning process and/or amendments to one or more of the OEB's applicable regulatory instruments, including the Distribution System Code, the Transmission System Code, the IESO's licence and utility application filing requirements.

The initial focus of the RPPAG will be to further assess certain recommendations resulting from the review undertaken by the Independent Electricity System Operator (IESO) of the regional planning process; specifically, those set out in the <a href="IESO's Straw">IESO's Straw</a> Man document (IESO Straw Man) that the OEB will lead.

While the primary focus in the near term will be the IESO's recommendations, the OEB does not plan to limit the scope of the RPPAG's work to those recommendations. There may be other areas where process efficiencies can be realized, as the OEB's ultimate goal is to improve the efficiency and effectiveness of the current regional planning process. However, to be clear, those recommendations that have been identified as

being spearheaded by the IESO are not within the scope of this review and will therefore not be a focus of discussion at the RPPAG meetings.

## **RPPAG Membership**

The OEB acknowledges all the organizations that responded to the December 10<sup>th</sup> letter expressing an interest in participating as a member of the RPPAG. The membership of the RPPAG reflects the qualifications set out in the December 10<sup>th</sup> letter. Regional diversity was also taken into consideration. All stakeholders that indicated an interest have been accepted for membership and form the newly constituted RPPAG asset out in Attachment A. OEB staff will be communicating directly with the RPPAG members regarding the date and a proposed agenda for the first meeting of the RPPAG.

#### **Cost Eligibility**

The December 10<sup>th</sup> letter indicated that cost awards will be available under section 30 of the *Ontario Energy Board Act, 1998*, and will be recovered from licensed electricity distributors and licensed electricity transmitters. Three stakeholders applied for cost eligibility.

The OEB has determined that the following stakeholders meet the criteria set out in the OEB's <u>Practice Direction on Cost Awards</u> (Practice Direction) and are therefore eligible for cost awards in this consultation:

- School Energy Coalition (Mark Rubenstein)
- Pollution Probe (Michael Brophy)
- Common Voice Northwest (lain Angus)
