Re: Sector Evolution Consultations: Utility Remuneration (EB-2018-0287) and

Responding to Distributed Energy Resources (EB-2018-0288)

As stakeholders will be aware, the Ontario Energy Board (OEB) published a series of expert reports by London Economics International LLC (LEI) on December 16, 2020. The OEB is now posting a Distributed Energy Resource (DER) Impact Study, prepared by ICF, which forecasts the adoption of distributed generation and storage in Ontario over the next 10 years. It also identifies potential signposts for the timing of regulatory policy responses.

The OEB is also inviting interested stakeholders to a meeting where LEI and ICF will present the results of their studies. In addition to discussing the experts' reports, stakeholders will be invited to discuss the implications of the studies on next steps in the OEB's policy work.

### **Background**

On September 24, 2020, the OEB issued a <u>letter</u>, advising stakeholders that it had commissioned expert studies by LEI and ICF to assist in confirming the scope and next steps, including pacing and sequencing, for the sector evolution consultations. The studies were completed and published on the OEB's website as follows:

# **LEI Reports:**

- <u>COVID-19 Impact Study</u> examines the economic and societal impacts from the COVID-19 pandemic on utility financial health and short- and long-term electricity and natural gas demand.
- <u>COVID-19 Impact on Distributed Energy Resources</u> examines the major drivers of DER adoption: cost savings, environmental benefits, better reliability, greater independence and government incentives.

## **ICF** Report:

 <u>DER Impact Study</u> (and <u>associated appendices</u>) forecasts the adoption of distributed generation and storage in Ontario over the next 10 years and identifies potential signposts for the timing of regulatory policy responses.

## **Stakeholder Meeting Details**
