The Ontario Energy Board (OEB) received NRG Kiosk LLC, DBA Power Kiosk's application for an Electricity Retailer (agent only) licence and gas marketer (agent only) licence on February 16, 2021. The OEB has assigned file number EB-2021-0085/EB-2021-0086 to the applications. The applications will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

The OEB has preliminary reviewed your application. Your applications are currently incomplete and cannot be processed until the following has been filed:

**1. Section 6: Applicant's Licensing Status and History**

You listed ER-2018-0317 and GM-2018-0318, according to the OEB records these licences expired on February 13, 2021. Pursuant to Section [57](#) of the OEB Act, no person can retail electricity unless licensed to do so. As per Section 48 of

the OEB Act, no person shall carry on business as a gas marketer unless the person holds a gas marketer's licence.

Please provide why you allowed your licence to expire and have not renewed in a timely manner in order to maintain compliance with Section 57 and Section 48 of the OEB Act.

The OEB will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments. The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
