### DECISION AND ORDER

On January 7, 2021, Narrows Green LP (Narrows Green) filed an application with the OEB under section 60 of the *Ontario Energy Board Act, 1998* (OEB Act) for an electricity storage licence.

On February 10, 2021, Envista Energy LP (Envista) and Demand Power Group Inc. (Demand Power) each filed a complete application with the OEB under section 60 of the OEB for an electricity storage licence.

Given the interrelated business relationship between the applicants, the OEB combined the applications into one proceeding, pursuant to section 21(5) of the OEB Act. This Decision and Order is being issued by the Delegated Authority without a hearing pursuant to section 6(4) of the OEB Act.

Envista and Narrows Green are special purpose entities formed for the purpose of owning behind the meter storage facilities. Specifically, Envista will own a 11.18 MW Evista Energy (Vision) battery storage facility located in Woodbridge, Ontario. Narrows Green will own a 2 MW Narrows Green (Agnora) battery storage facility located in Collingwood, Ontario. Demand Power will be operating the subject storage facilities and will be managing daily operating activities of Envista and Narrows Green. Electricity will be provided to large volume industrial customers under retail power purchase agreements<sup>1</sup>.

After considering the evidence and assessing technical capability and financial viability of the applicants, the OEB finds that it is in the public interest to grant the applications and issue an electricity storage licence to each Envista Energy LP, Narrows Green LP and Demand Power Group Inc.

### IT IS ORDERED THAT:

1. The application by Envista Energy LP for an electricity storage licence is granted, on such conditions as are contained in the attached licence.

- 2. The application by Narrows Green LP for an electricity storage licence is granted, on such conditions as are contained in the attached licence.
