Regarding the decision and the accompanying draft Rate Order.

Lakeland Power Distribution Ltd. agrees with the decision within the draft order. However, the tariff sheet that accompanied the order is missing the approved rates for the former Parry Sound service area that are in effect until October 31, 2021, a result of rate impacts from COVID-19 deferral at May 1, 2020. The differences are as below:
