Re: Halton Hills Hydro Inc. 2021 Cost of Service Rate Application, Revision to the Draft Rate Order (DRO)
Board No.: EB-2020-0026

On August 27, 2020, Halton Hills Hydro Inc. filed an application with the Ontario Energy Board (“OEB” or the “Board”) under Section 78 of the *Ontario Energy Board Act, 1998* as amended and pursuant to the OEB’s *Filing Requirements for Incentive Rate-setting Applications* seeking approval for electricity distribution rates, and other charges, effective May 1, 2021.

The Board issued a Decision and Order in this matter on March 18, 2021. The Board directed Halton Hills Hydro Inc. to file a Draft Rate Order by March 25, 2021, that incorporates the OEB’s determinations in its Decision and Order. The Draft Rate Order was filed accordingly.

It was determined after the filing that the submitted Tariff Schedule and Bill Impact Model required additional updating which included updated Regulated Price Plan rates and Ontario Electricity Rebate.

Halton Hills Hydro Inc. has filed an updated Tariff Schedule and Bill Impact Model (in live Excel format) in addition to a pdf version of the updated draft 2021 Tariff of Rates and Charges and Bill Impacts (attached as Appendices A and B respectively).

Customers shall be residing in single-dwelling units that consist of a detached house or one unit of a semi-detached, duplex, triplex or quadruplex house, with a residential zoning. Separately metered dwellings within a town house complex or apartment building also qualify as residential customers. The customer will be supplied at one service entrance only. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.
