I act as legal counsel for the City of Mississauga. Please accept this letter of intervention on behalf of my client confirming its intention to acquire intervenor status in the above reference application.

In accordance with Section 22.03 of the Rules of Practice and Procedure before the Ontario Energy Board, the undersigned wishes to confirm the following:

- (a) The intervenor is a municipal corporation in the Province of Ontario and is interested in the application as the registered owner of the lands over which the applicant seeks to expropriate an easement interest;
