**Application for approval to expropriate interests in
certain lands along a pipeline route in the City of
Mississauga and the City of Toronto**

PROCEDURAL ORDER NO. 1

April 7, 2021

Imperial Oil Limited (Imperial Oil) applied to the Ontario Energy Board (OEB) on February 23, 2021 under section 99 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), for an order granting the approval to expropriate interests in certain lands along a pipeline route in the City of Mississauga and the City of Toronto. Under a separate Decision and Order dated March 12, 2020, (with modifications approved in December 17, 2020) Imperial Oil received OEB's approval to construct the pipeline and associated facilities to transport refined fuel products from Imperial Oil's facility in the City of Hamilton to its facility in the City of Toronto.

A Notice of Hearing was issued on March 11, 2021. The City of Mississauga applied for intervenor status. No objection was received from Imperial Oil.

The City of Mississauga is approved as an intervenor. The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Interrogatories

At this time, provision is being made for written interrogatories. Parties should not engage in detailed exploration of items that do not appear to be material. In making its decision on cost awards, the OEB will consider whether intervenors made reasonable efforts to ensure that their participation in the hearing was focused on material issues.

Parties should consult sections 26 and 27 of the OEB's [Rules of Practice and Procedure](#) regarding required naming and numbering conventions and other matters related to interrogatories.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff and the City of Mississauga shall request any relevant information and documentation from Imperial Oil that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by, **April 21, 2021**.
2. Imperial Oil shall file with the OEB complete written responses to all interrogatories and serve them on the City of Mississauga by, **May 5, 2021**.
3. Any written submissions from OEB staff and the City of Mississauga, shall be filed with the OEB and served on all parties by, **May 19, 2021**.
4. Any written reply submissions from Imperial Oil shall be filed with the OEB and served on intervenors by, **June 2, 2021**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, do not include personal information (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.

All materials filed with the OEB must quote the file number, **EB-2021-0096**, and be submitted in a searchable/unrestricted PDF format with a digital signature through the OEB's web portal at <https://p-pes.ontarioenergyboard.ca/PivotalUX/>. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address.
