AFFIDAVIT OF SERVICE

I, Bonnie Jean Adams, of the City of Vaughan, make oath and say as follows:

1. I am in the employ of Enbridge Gas Inc. (Enbridge Gas) and as such have knowledge of the matters hereinafter deposed to.
2. Between the months of October and December 2020, a search of title (Exhibit A) was conducted to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed pipeline and related facilities.
3. 

Enbridge Gas Inc. has applied for approval to construct approximately 19.8 kilometres of natural gas pipeline and ancillary facilities in the City of Ottawa.

If the application is approved as filed, Enbridge Gas Inc. will replace the existing St. Laurent Pipeline in two final phases (Phase 3 and Phase 4) of its multiple year project. In Phase 3, Enbridge Gas Inc. proposes to construct polyethylene pipeline of intermediate pressure consisting of approximately 4.2 kilometres of 6-inch diameter pipe, 3.6 kilometres of 4-inch diameter pipe and 383 metres of 2-inch diameter pipe to maintain gas distribution to its customers on the existing pipeline to be abandoned. In Phase 4, Enbridge Gas Inc. proposes to replace the existing extra high-pressure steel St. Laurent Pipeline with approximately 8.9 kilometres of 12-inch diameter pipe, 2.4 kilometres of 16-inch diameter pipe and 330 metres of 6-inch diameter pipe.

A map of the proposed pipeline project is provided below.



Enbridge Gas Inc. is also asking the Ontario Energy Board to approve the forms of agreement it offers to landowners to use their land for routing or construction of the proposed pipeline.

Enbridge Gas Inc. says that the project is needed to address pipeline integrity concerns related to the age and condition of the St. Laurent Pipeline.

THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Enbridge Gas’s application. During the hearing, which could be an oral or written hearing, we will question Enbridge Gas on the case. We will also hear questions and arguments from

individual consumers, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.

As part of its review of this application, the OEB will assess Enbridge Gas’s compliance with the OEB’s Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

The OEB will also assess whether the duty to consult with Indigenous communities potentially affected by the proposed pipeline has been discharged with respect to the application.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.



Enbridge Gas Inc. a déposé une requête en vue d'obtenir l'autorisation de construire un gazoduc de 19,8 kilomètres environ et des installations auxiliaires dans la ville d'Ottawa.

Si la demande est approuvée telle quelle, Enbridge Gas Inc. remplacera le pipeline de St-Laurent au cours des deux dernières phases (phase 3 et phase 4) de son projet pluriannuel. En phase 3, Enbridge Gas Inc. propose de construire un gazoduc en polyéthylène à pression intermédiaire composé d'environ 4,2 kilomètres de conduites de 6 pouces de diamètre, de 3,6 kilomètres de conduites de 4 pouces de diamètre et de 383 mètres de conduites de 2 pouces de diamètre pour maintenir la distribution du gaz à ses clients sur le gazoduc existant à abandonner. En phase 4, Enbridge Gas Inc. propose de remplacer le pipeline de St-Laurent existant en acier à très haute pression par environ 8,9 kilomètres de conduites de 12 pouces de diamètre, 2,4 kilomètres de conduites de 16 pouces de diamètre et 330 mètres de conduites de 6 pouces de diamètre.

Enbridge Gas Inc. demande également à la Commission de l'énergie de l'Ontario d'approuver la forme de l'entente qu'elle propose aux propriétaires fonciers afin d'utiliser leurs terres pour le tracé ou la construction du gazoduc proposé.

Enbridge Gas Inc. affirme que le projet est nécessaire pour régler les problèmes d'intégrité du gazoduc liés à l'âge et à l'état du pipeline de St-Laurent.

**LEAVE TO CONSTRUCT APPLICATION: ST. LAURENT NORTH OTTAWA
PIPELINE REPLACEMENT PROJECT**

1. The Applicant, Enbridge Gas Inc. (Enbridge Gas or the Company) is an Ontario corporation with its head office in the City of Toronto. It carries on the business of selling, distributing, transmitting, and storing natural gas within the province of Ontario.
2. Enbridge Gas has identified the need to replace approximately 16 km of Nominal Pipe Size (NPS) 12 inch extra-high pressure (XHP) steel (ST) natural gas main and approximately 400m of NPS 16 XHP ST natural gas main in the City of Ottawa, Ontario. The proposed St. Laurent North Ottawa Replacement Pipeline Project (Project) was identified in Enbridge Gas’s asset management plan as part of the EB-2018-0305 proceeding. Replacement of the pipeline is to occur over multiple phases over multiple years. Phase 1 and Phase 2 of the Project were discussed in the EB-2019-0006 proceeding and part of Phase 2 was granted leave to construct by the Ontario Energy Board (OEB or the Board) in that proceeding. This current application is seeking leave to construct approval for Phase 3 and Phase 4 of the Project.

3. In this application, Enbridge Gas has identified the need to abandon and replace approximately 16 km of nominal pipe size (NPS) 12 inch extra-high pressure (XHP) steel (ST) natural gas main and approximately 400 m of NPS 16 XHP ST natural gas main in the City of Ottawa, Ontario. The pipelines to be abandoned will be replaced with approximately 9 km of NPS 12 XHP ST and approximately 2.4 km of NPS 16 XHP ST natural gas pipeline.
4. For ease of reference and to assist the Board with preparation of the notice of application for this Project, a map of the proposed facilities is included at Attachment 1 to this Exhibit.
5. The St. Laurent Pipeline is a critical part of the natural gas distribution system in the City of Ottawa. The St. Laurent Pipeline directly and indirectly supplies approximately 165,000 customers in the City of Ottawa and in Gatineau. The Project is necessary as there are a number of integrity concerns along the length of the pipeline that are in part due to the vintage of the main. The St. Laurent Pipeline is a vintage steel distribution main that was installed prior to 1970. The St. Laurent Pipeline has a number of conditions that are outlined in this pre-filed evidence and Enbridge Gas has determined that the replacement of the St. Laurent Pipeline is needed to ensure the safe and reliable supply of natural gas to customers in Ottawa and Gatineau.
6. Enbridge Gas expects to commence construction of the Project in August of 2021. In order to meet Project timelines, the Company respectfully requests the Board grant leave to construct approval of this application as soon as possible and not later than July 2021.



Project information

As Enbridge Gas is regulated by the Ontario Energy Board (OEB), this Project is being planned in accordance with OEB regulations. The OEB acts as a regulatory body to protect the public interest, to determine that the Project is necessary, and to ensure that Enbridge Gas obtains the necessary approvals to meet health, safety, and environmental standards and regulations.

For OEB approval, an Environmental Report (ER) must be submitted with the Leave-to-Construct application to the OEB. The ER documents the environmental study conducted for the project, which identifies potential environmental and socio-economic effects that the Project could have on the existing physical, natural, and socio-economic environment. Mitigation measures designed to reduce environmental and socio-economic effects are also developed as part of the Study. The ER conforms to the OEB Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario, 7th Edition (2016). The ER must document that municipal, provincial, and federal agencies, as well as the concerns of Indigenous communities, were considered. Concerns identified by landowners and the public must also be addressed.
