Re: Generate Two Path 21 Fenmar GP Inc. on behalf of Generate Two Path 21 Fenmar LP Application for Electricity Generator Licence OEB File Number EB-2021-0112

The Ontario Energy Board (OEB) received Generate Two Path 21 Fenmar GP Inc. on behalf of Generate Two Path 21 Fenmar LP's (Generate) application for an electricity generator licence on March 15, 2021. The OEB has assigned file number EB-2021-0112 to the application. The application will be decided by an employee of the OEB who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998* (Delegated Authority). The Delegated Authority intends to make a decision on the application without holding a hearing.

The OEB has preliminary reviewed your application. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Section 8 (c), Page 5: Intended Services and Markets

In your application, you indicated that you intend to generate electricity for sale to another person and that this person is a consumer. Please provide a timeline for filing an electricity retailer licence application that will enable Generate to sell power to a consumer.

2. Section 10, Page 6: Facility History and Status

This section requires the applicant to provide information on all other regulatory approvals required and identify status of each approval. No information on other regulatory approvals has been provided in the application by Generate. Please provide the required information.

3. Section 11, Page 7: Connection

Please provide a diagram demonstrating all components of the generation facility, distribution assets to connect to the customer's facility and the connection point to the customer's facility. Please identify the ownership of all components included in the diagram, i.e. if the components are owned by the applicant or the customer.

4. Section 14, Page 10: Technical Resources:

In your application, you identified two organizations, Great Circle Power Corporation and Ainsworth, that the applicant has retained to assist with administration and operations and maintenance of the facility.

Please describe these companies and their expertise with respect to the services these companies will be providing to Generate.

The OEB will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Once your application is complete, the Delegated Authority expects to issue a final decision on your application within 60-90 days.

In the event the Delegated Authority decides to deny or otherwise modify the relief you requested in your application, you will be given an opportunity to provide comments.

The Delegated Authority will consider your final comments, if any, prior to issuing a decision and order.
