**Application for payment amounts for the period from
January 1, 2022 to December 31, 2026**

**PROCEDURAL ORDER NO. 3
May 13, 2021**

Ontario Power Generation Inc. (OPG) filed an application dated December 31, 2020, with the Ontario Energy Board (OEB) under section 78.1 of the *Ontario Energy Board Act, 1998* seeking approval for changes in payment amounts for the output of its nuclear generating facilities in each of the five years beginning January 1, 2022 and ending on December 31, 2026. OPG also requested approval to maintain, with no change, the base payment amount it charges for the output of its regulated hydroelectric generating facilities at the payment amount in effect December 31, 2021 for the period from January 1, 2022 to December 31, 2026.

Confidential Filings

Pursuant to Procedural Order No. 1, OPG filed responses to interrogatories filed by intervenors and OEB staff. In letters dated April 30, 2021 and May 11, 2021, OPG requested confidential treatment of a number of interrogatory responses, or certain portions thereof. A complete list of affected interrogatory responses is attached as Schedule A to this Procedural Order.

OPG also proposed to permanently redact, without disclosure except to the OEB ("OEB Review Only"), certain information in a board memo dated October 19, 2020 prepared in relation to the Amended 2020-2026 Business Plan. This board memo was attached to the response provided to interrogatory CCC-015.

In accordance with the OEB's Practice Direction on Confidential Filings, OPG has filed redacted versions of the documents as part of its public filing (except for the documents that OPG seeks confidential treatment in their entirety) and unredacted versions as part of its confidential filing.

The OEB will provide other parties with an opportunity to object to OPG's request for confidential treatment of interrogatory responses filed by OPG. Objections should be organized based on the confidentiality request number(s), ranging from 1 to 100 as listed in Schedule A.

For "OEB Review Only" documents, the OEB will determine if the information should be permanently redacted in a subsequent decision.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

THE ONTARIO ENERGY BOARD THEREFORE ORDERS THAT:

1. If OEB staff or intervenors wish to object to OPG's request for confidentiality in relation to the interrogatory responses (excluding the "OEB Review Only" document), they shall file written submissions with the OEB and deliver them to OPG and all other parties by **May 20, 2021**.
2. If OPG wishes to respond to the submissions, it shall file such submissions with the OEB and deliver them to parties by **May 27, 2021**.

How to File Materials

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
