

# ONTARIO ENERGY BOARD NOTICE TO CUSTOMERS OF LAKEFRONT UTILITIES INC.

**Lakefront Utilities Inc. has applied to increase its electricity distribution rates.**

**Learn more. Have your say.**

Lakefront Utilities Inc. has applied to the Ontario Energy Board to increase its electricity distribution rates effective January 1, 2022. If the application is approved as filed, a typical residential customer and a typical general service customer of Lakefront Utilities Inc. would see the following change.

Residential 750 kWh	\$1.30 per month
General Service less than 50kW (2,000 kWh)	\$3.72 per month

Lakefront Utilities Inc. has also applied for approval to establish two new Specific Service Charges and a Standby Charge for the General Service 50-2999 kW and General Service 3000-4999 kW customer classes. It is important to review the application carefully to determine whether you may be affected by these changes.

## THE ONTARIO ENERGY BOARD WILL HOLD A PUBLIC HEARING

The OEB will hold a public hearing to consider Lakefront Utilities' application. During this hearing, which could be an oral or written hearing, we will question Lakefront Utilities on its case for a rate change. We will also hear questions and arguments from individuals that have registered to participate (called intervenors) in the OEB's hearing. At the end of this hearing, the OEB will decide what, if any, rate increase will be allowed.

Distributors such as Lakefront Utilities typically apply for a full review of their rates every five years. Any rate changes for the years in between are made by applying an OEB-approved formula which is tied to inflation and other factors intended to promote efficiency. You may not get notice of future rate changes made by applying the formula.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

## BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

- You can review Lakefront Utilities' application on the OEB's website now
- You can file a letter with your comments, which will be considered during the hearing
- You can become an intervenor. As an intervenor, you can ask questions about Lakefront Utilities' application and make arguments on whether the OEB should approve Lakefront Utilities' request. Apply by **June 7, 2021** or the hearing will go ahead without you and you will not receive any further notice of the proceeding
- At the end of the process, you can review the OEB's decision and its reasons on our website

These proposed charges relate to Lakefront Utilities' distribution services. They make up part of the Delivery line - one of the line items on your bill. The OEB will determine at a later date whether to proceed by way of a written or oral hearing. If you think an oral hearing is needed, you can write to the OEB to explain why by **June 7, 2021**.

However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.*
