**Re: Additional Information – Request for Intervenor Status
Application for Revenue Requirement, Expenditures and Usage Fees for
2020 and 2021
Ontario Energy Board File Number: EB-2020-0230**

This letter is in response to Power Advisory's letter to the Ontario Energy Board (OEB) dated July 16, 2021, providing additional information on its specific interest in the proceeding in relation to its intervention request.

The OEB issued Procedural Order No. 1 on July 15, 2021 and denied the intervention request of Power Advisory, representing jointly, Canadian Renewable Energy Association (CanREA), Energy Storage Canada (ESC) and Ontario Waterfront Association (OWA). In Procedural Order No. 1, the OEB advised that Power Advisory could provide additional information on its specific interest in this proceeding, and the OEB would reconsider.

Power Advisory's letter dated July 16, 2021 stated that its specific interest in the proceeding is that "approximately 50 companies within CanREA, ESC and OWA operate renewable generation and energy storage facilities as registered wholesale market participants within the IESO-Administered Markets (IAM), therefore have direct insights regarding how IAM is administered, and have actively participated within IESO stakeholder engagement initiatives that directly relate to priority initiatives within IESO's business plan". Power Advisory's July 16, 2021 letter also noted that CanREA, ESC and OWA understands that the OEB expects its review of the IESO's application will be a focused review, directed towards discrete elements such as capital and OM&A.

The OEB grants the intervention request of Power Advisory, representing jointly, CanREA, ESC and OWA pursuant to Rule 22.02 of the OEB's [Rules of Practice and Procedure](#).

Power Advisory, representing jointly, CanREA, ESC and OWA, is granted cost eligibility. The OEB requires that CanREA, ESC and OWA coordinate their participation on common issues and avoid duplication. In making its decision on costs awards the OEB will consider whether CanREA, ESC and OWA made reasonable efforts to avoid duplication, and to ensure that their participation in the hearing was focused on material issues.

The OEB will not generally allow the recovery of costs for the attendance of more than one representative of any party, unless a compelling reason is provided when cost claims are filed. Being eligible to apply for recovery of costs is not a guarantee of recovery of any costs claimed. Cost awards are made by way of OEB order at the end of a hearing.
