## **Independent Electricity System Operator**

## Application for Approval of 2020 and 2021 Expenditures, Revenue Requirement and Fees

## PROCEDURAL ORDER NO. 2 July 23, 2021

The Independent Electricity System Operator (IESO) filed an application with the Ontario Energy Board (OEB) on May 27, 2021 under section 25(1) of the *Electricity Act,* 1998, seeking approval for its 2020 and 2021 expenditures, revenue requirement and fees.

The OEB issued Procedural Order No. 1 on July 15, 2021, which, among other things, scheduled deadlines for interrogatories, responses to interrogatories and scheduled a settlement conference. The OEB is revising the dates for the above-mentioned steps. The deadlines for items 6-9 in Procedural Order No. 1 remain the same.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

## THE ONTARIO ENERGY BOARD ORDERS THAT:

- OEB staff and intervenors shall request any relevant information and documentation from the IESO that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on all parties by August 19, 2021.
- 2. The IESO shall file with the OEB complete written responses to all interrogatories and serve them on OEB staff and all intervenors by **September 9, 2021**.
- 3. A settlement conference among the parties and OEB staff will be convened on **September 15, 2021** starting at 9:30 a.m. If necessary, the settlement conference will continue on **September 17, 2021** and **September 20, 2021**. This will be a virtual event and information on how to participate will be provided in advance of the conference.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
