## 1 OVERVIEW

This is a Decision and Rate Order of the Ontario Energy Board (OEB) on an application filed by Newmarket-Tay Power Distribution Ltd. (Newmarket-Tay Power) for approval of its electricity distribution rates to be effective May 1, 2021.

Newmarket-Tay Power sought approval of the Annual IR Index option to set rates for the Newmarket-Tay Rate Zone (NTRZ) and of the Price Cap Incentive Rate-setting option for the Midland Rate Zone (MRZ) for 2021. Newmarket-Tay Power also sought approval of two Incremental Capital Modules (ICM) for the NTRZ.

The OEB issued its Decision and Order (Decision) on the application on April 22, 2021. In the Decision, the OEB ordered Newmarket-Tay Power to file a draft rate order (DRO) reflecting the OEB's findings. On April 28, 2021, Newmarket-Tay Power filed a DRO. On May 5, 2021, OEB staff filed its submission on the DRO. The OEB staff submission included an updated Tariff of Rates and Charges. Newmarket-Tay Power agreed with OEB staff's updates.

The OEB has reviewed Newmarket-Tay Power's DRO and supporting schedules, as revised. The OEB approves the 2021 Tariff of Rates and Charges (see Schedule A).

The total bill impact for a typical residential customer with a monthly consumption of 750 kWh will be a decrease of \$0.92 per month or 0.71% in the NTRZ and an increase of \$1.14 per month or 0.84% in the MRZ, for the 2021 rate year. The bill impacts do not factor in applicable taxes or the Ontario Electricity Rebate.

## 2 CONTEXT AND PROCESS

Newmarket-Tay Hydro filed an application with the OEB to change its electricity distribution rates effective May 1, 2021.

The application was supported by pre-filed written evidence and a completed Rate Generator Model. During the course of the proceeding, the applicant responded to interrogatories and, where required, updated and clarified the evidence. The OEB issued its Decision on the application on April 22, 2021, and established the process for a DRO, as well as submissions on the DRO.

Pursuant to the Decision, Newmarket-Tay Power filed a DRO on April 28, 2021. OEB staff filed its submission in response to the DRO on May 5, 2021, together with a revised Tariff of Rates and Charges to properly account for the unique situation of two volumetric rates in the 50-4,999 kW customer class. Newmarket-Tay Power filed its reply to OEB staff's submission on May 10, 2021, noting its agreement with the revisions.

### 3 DECISION ON THE DRAFT RATE ORDER

In its Decision, the OEB approved Newmarket-Tay Power's request to apply the Annual IR Index option to set rates for the NTRZ, and the Price Cap Incentive option to set rates for the MRZ, for 2021. The OEB approved May 1, 2021 as the effective date for the new rates, and invited Newmarket-Tay Power to include in its Draft Rate Order a calculation of forgone revenue from May 1, 2021 to June 1, 2021 and include in its Tariff of Rates and Charges a forgone revenue rate rider to be collected over an eleven-month period commencing June 1, 2021, in the event that Newmarket-Tay Power's rate order was not issued in time for Newmarket-Tay Power to implement rates for May 1, 2021. Newmarket-Tay Power did not include a forgone revenue calculation or rate rider in its Tariff of Rates and Charges or its reply submission. Accordingly, the OEB understands that Newmarket-Tay power does not consider those measures necessary.

The OEB also made its determination on the ICM application for payments to Hydro One Networks Inc. for construction of a new substation. The OEB approved funding for the payment forecast to be made in 2021 and denied funding for a payment previously made in 2015. The OEB finds that Newmarket-Tay Power, in its DRO, implemented the OEB's findings in the Decision.

OEB staff submitted a revised Tariff model to properly calculate two volumetric rates in the 50-4,999 kW customer class and asked that Newmarket-Tay Power comment on the revisions in its reply. Newmarket-Tay Power advised of its agreement with the OEB staff revisions in its reply, and no parties raised concerns regarding the revised Tariff model prepared by OEB staff. The OEB approves the Tariff of Rates and Charges as filed by OEB staff on May 5, 2021.

## 4 IMPLEMENTATION AND ORDER

### THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and charges set out in Schedule A of this Decision and Rate Order is approved as final effective May 1, 2021. The Tariff of Rates and Charges will apply to electricity consumed, or estimated to have been consumed, on and after May 1, 2021. Newmarket-Tay Power Distribution Ltd. shall notify its customers of the rate change no later than the delivery of the first bill reflecting the new final rates.

## RESIDENTIAL SERVICE CLASSIFICATION

This classification refers to the supply of electrical energy to customers residing in residential dwelling units. Energy is generally supplied as single phase, 3-wire, 60-Hertz, having nominal voltage of 120/240 Volts and up to 400 amps. There shall be only one delivery point to a dwelling. The Basic Connection for Residential consumers is defined as 100 amp 120/240 volt overhead service. A Residential building is supplied at one service voltage per land parcel. Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.

## APPLICATION

The application of these rates and charges shall be in accordance with the Licence of the Distributor and any Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, which may be applicable to the administration of this schedule.

No rates and charges for the distribution of electricity and charges to meet the costs of any work or service done or furnished for the purpose of the distribution of electricity shall be made except as permitted by this schedule, unless required by the Distributor's Licence or a Code or Order of the Ontario Energy Board, and amendments thereto as approved by the Ontario Energy Board, or as specified herein.

### **GENERAL SERVICE 50 TO 4,999 KW SERVICE CLASSIFICATION**

This classification applies to a non residential account whose average monthly maximum demand used for billing purposes is equal to or greater than, or is forecast to be equal or greater than, 50 kW but less than 5,000 kW. Note that for the application of the Retail Transmission Rate - Network Service Rate and the Retail Transmission Rate - Line and Transformation

Connection Service Rate the following sub-classifications apply:

General Service 50 to 500 kW non-interval metered

General Service 50 to 500 kW interval metered

General Service greater than 500 to 5,000 kW interval metered.

Class A and Class B consumers are defined in accordance with O. Reg. 429/04. Further servicing details are available in the distributor's Conditions of Service.
